Circumstances

3. The Politicians made a Civil Dictator Governance Plan for Western Europe. It used a Corruption Remedy Monopoly for the State. It had two Fundamental Flaws. One was that it relied on Electronic Signature Dictator Powers. It was doomed if Advanced Electronic Signatures provided by the Citizen got Profitable Use anywhere in the world. The other was dependence on Sabotage Frauds against the Coronation Oath Enforcement Authority until no one knew how to service it, and then that it existed. It was doomed if the Citizen got Criminal Conspiracy Proof against a serving Prime Minister and used it to revive the Coronation Oath Enforcement Authority before everyone forgot how to service it. In every Member State of the European Union the Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and manage Co-ordinated Corruption. They sold Market Frauds to Organised Crime, provided Protection Frauds for the Corrupt Officers who managed them and traded Glittering Career Guarantees and Job Profits for Fraud Services by Corrupt Parliamentarians.
4. The Gnostic Christians made an Equity Governance Recovery Plan. It had two strategies each of which exploited the Fundamental Flaws. Equity Lawyer Mr Ellis developed Advanced Electronic Signatures. The Profit Plan was On Line Services. The Defence Plan was Source Code Secrecy to get Unending Copyright. The European Leaders made a Private Profit Plan. It needed Source Code Theft, Forced Usage in the European Union and Usage Licence Fees for the Theft Conspirators. It failed. Bad Execution enabled the Equity Lawyer to get Theft Conspiracy Proof. They made a Market Exclusion Fraud Plan against Advanced Electronic Signatures and a Ruin Fraud Plan against the Equity Lawyer. In 204 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Equity Lawyer and Queen Elizabeth II used it to revive the Coronation Oath Enforcement Authority and start a Corruption Remedy Process that has continued ever since.
5. The Passport Denial Fraud is the last in the Ruin Fraud Series. The Kidney Failure Dialysis Treatment Nurse Manager has led the Nurse Team that has kept the Equity Lawyer alive since April 2020. Identity Verification by him got Identity Verification Denial Fraud Proof against the Passport Office
