Election Service Negligence Grievance

1. The Wrong is Hustings Management Negligence. It denied the People use of Remedy Proposals, to which there is No Credible Objection, for Integrity Tests of Election Managers and Election Candidates. They are:
 - 1.1. Global Cooling using Equatorial Satellites and Polar Satellites for Heat Defection from earth to space.
 - 1.2. Pollution Control by converting Fluid Sewage into Solid Nitrate Fertiliser to protect rivers and seas
 - 1.3. Corruption Control by use of Common Law Accountability Powers for the Victims and Citizen
2. The function of the Good Will Religions is to provide Clergy who stand in pulpits, preach the Good Will Message, prophesy Bad Will Damage and provide Remedy Management Services. Good Will Religions use Churches Together for Joint Remedy Action. They provided Hustings Services with many others. All Hustings Events had Limited Publicity. Others stopped and Churches Together carried on. They did not realise that Fewer Hustings Events needed More Publicity.
3. Governance Frauds by Corrupt Officers did Corruption Damage got Hostile Behaviour by Victims. Effective Remedies need Case Management Contact between the Aggrieved and the Aggriever or whoever has Remedy Powers. It is proportionate to the Case Complexity.
4. Endemic Corruption created the need for Remedy Contact between Voters and Candidates. It did not get Remedy Contact. It got Contact Denial that was Protection Frauds for Corrupt Officers against Victims. On the evidence available the Clergy did not realise Protection Frauds were Bad Will Damage that needed Remedy Management.
5. Big Pharma bought Market Frauds for Drug Treatment against Other Treatment. They were Protection Frauds for Drug Research Frauds, Human Organ Thefts and Sabotage Frauds against Homeopathic Medicine. One was creation of the General Osteopathic Council to manage Governance Frauds against Registered Osteopaths.
6. Viagra Research got a Bad Aside Effect Report by Dr Spivack and Dismissal Fraud against her by Pfizer. It sent a Shock Wave through the Drug Research Community. She did not know the General Osteopathic Council was created to manage Governance Frauds against Registered Osteopaths. got Osteopath Qualifications
7. In 2000, Corruption Complaints in more than 200 Parliamentary Constituencies got a Corruption Debate + Investigation Commitment + Investigation Denial Frauds + Protection Frauds for the General Osteopathic Council that continue in 2024.
8. Health Knowledge and a Special Gift enable Dr Spivack to correlate the Human Electromagnetic Field with health Problems. Special Insights need Academic Freedom and Peer Support to develop Insight Communication Skills. Career Sabotage Frauds against Dr Spivack denied the Peer Support. Corruption Sympathy by the Mid Bedfordshire MP motivated Dismissal Frauds against him and Appointment Frauds for Ms Nadine Dorries, who was the Market Fraud Minder for Big Pharma in Parliament. It got Political Representation Denial Frauds from 2005 to 2023 by MP Ms Dorries against Dr Spivack. In 1st January 2014 Dr Spivack discovered the Coronation Oath Enforcement Authority and the Remedy process they manage. She has serviced it ever since. She agreed to service the Hustings Test
