Stated Reasons

1. The Parliament Sessions Court is managing Forced Corruption Remedies by Parliament. It needs Integrity Test Cases. It needs Governance Fraud Mass Claim Lead Cases Offers by Citizens as Integrity Tests to discover whether they get Mass Claim Publicity by Media Managers. It needs Incapacity Exploitation Fraud Test Cases that cannot be used as Mass Claim Lead Cases. In February 2020 a Case Reference of the Lease Possession Claim F21YY087 by Case Document Printers for Mrs Tedla got Repeat Case Evidence Requirements from the Equity Lawyer and Repeat Requirements Failures by her for 4 years and 5 months that are Case Management Incapacity Proof. It, the involvement Central London County Court Top Judges as Supervising Judges and Case Judges and the Appeal Hearing on 1st August 2024 are Excellent Qualifications for the Incapacity Exploitation Test Case.
2. In 2021 the Corruption Remedy Priority of the Parliament Session was Credibility Recovery for the Authorities. It needed Dismissal Executions by a United Parliament, Victim Identification and Case Remedies. Dismissal Failures were Protection Fraud Proof against the Cabinet. The Default Penalty was a Dismissal Decision against Prime Minister Mr Johnson. Dismissal help Requests by Governing Majority MPs got Help Refusals by Opposition Leader Sir Keir Starmer. He kept Prime Minister Mr Johnson in office and used the Covid Regulation Party Breach Scandal for a Dismissal Pretence Fraud. It was Protection Fraud Proof that got a Dismissal Decision against Parliament. It created the need to use Corruption Exposure to get an MP for a Forced Dismissal against the Governing Majority and Forced Credibility Recovery by whoever won the General Election. It needed Imprisonment Fraud Proof against the Law Courts and use of it for an Imprisonment Fraud Finding + Protection Fraud Finding + Enforcement Fraud Finding by the Parliament Sessions Court. Then it needed Corruption Exposure Threats to get Forced Finding Pronouncements by Parliament and then an International Agreement for Remedy Enforcement against Fraud Profiteers. It needed a series of cases to get the Proof Sets.
3. In 2022 the Contempt Claim of Equity Lawyer Mr Ellis against Prime Minister Mr Johnson, Ministry of Justice, the Attorney General and Opposition Leader Sir Keir Starmer was an Election Integrity Tests Case of the Law Courts and Major Party Leaders. Case Filing got 153 Day Issue Denial Fraud Proof + Case Reference 2022 002595 Issue Proof + General Civil Restraint Renewal Fraud Proof against the High Court. Courtesy Notice was given to Romford County Court in Mortgage Possession Case H1PP8822 of Bank of Scotland v Sadhana Chaudhari Probate

Estate because he was the Will Executor. It got Case Reference J00RM833 Issue Fraud against the County Court. The Issue Fraud + Case Management Frauds and Issue Denial Frauds + General Civil Restraint Renewal Fraud were Fraud Conspiracy Proof against the County Court and High Court and Fraud Beneficiary Proof against the Defendants. The Parliament Sessions Court used Session Power Threats to get a Forced Prosecution of Contempt Claim 2022 003098 by the Cabinet against the Equity Lawyer. It got a Complete Set of Trial Fraud Proof and Imprisonment Fraud Proof against the High Court. It enabled a Corruption Investigation by the Equity Lawyer and Honourable Officers that got Fraud Conspiracy Proof against the Prison Authorities and Law Courts. It enabled the Parliament Session Court to make the Forced Remedies Findings Set and get the Forced Finding Pronouncements. The 17 Years Imprisonment Fraud Case, Police Video Concealment Frauds and Drug Dealing Prison Officers were Demonstration Cases. In December 2023 the G7 Summit got an International Agreement for Remedy Enforcement against Fraud Profiteers.

4. In 2024 the Parliament Session Court forced use of the Post Office Scandal and Health Scandals to get Mass Publicity for Corruption Exposure of the State up to Cabinets, Remedy Denial Fraud Proof against Law Courts, Remedy Efforts by Honourable Individuals and Mass Remedies by Parliament. Integrity Test got Corruption Continuity Proof against the Fraud Profiteers, State, Profession Authorities and Law Courts. It increased the Retirement Rate of Governing Majority MPs and a Power Imbalance Exploitation Frauds by Sir Keir Starmer. One was a Corrupt Deal that used Bias Frauds by the House of Commons Speaker for the Labour Party as the 1st Opposition Party against the Scottish National Party as the 2nd Opposition Party as Bias Fraud Commitment Proof for the New Governing Majority led by Sir Keir Starmer against the New Opposition Minority in exchange for Sir Lindsay Hoyle keeping the office of House of Commons Speaker after the General Election. Another was Revenue Termination Blackmail by Big Business and Sir Keir Starmer to get Election Fraud Services by the BBC and ITN that denied Proportionate Publicity for the Protection Fraud Proof against the offices of Director of Public Prosecutions and Opposition Leader when Sir Keir Starmer held them. Election Integrity Tests got Fraud Conspiracy Prof against the Fraud Profiteers, Media Managers, State, Profession Authorities, Law Courts, Candidates and Party Leaders. The result was an Incredible Choice for Voters, a Split Majority Vote for Traditional Conservative Values enabled a Minority Vote to get a Landslide Governing Majority led by Sir Keir Starmer. The BBC Licence Fee Decision was the Crime Proceeds of the Election Fraud Conspiracy.
5. The Election Integrity Tests got the Husting Negligence Claim by Mid Bedfordshire Constituent Dr Spivack against Churches Together, the Cabinet, Electoral Commission, BBC and ITN got Issue Denial Fraud Proof against the High Court and Fraud Beneficiary Status for All Defendants. The Issue Denial Fraud gets Admissible Evidence Status for All Case Communications in the Parliament Sessions Court. The BBC Licence Fee is a Case Issue. It influenced the decision of ITN to use the Strictly Come Dancing Scandal for Licence Fee Sabotage against the BBC. The Forced 20,000 Prison Release Reason Frauds ignored the Release Delay Frauds by Opposition Leader Sir Keir Starmer.
6. Governance Fraud Mass Claims Lead Case Offers are Integrity Tests that will get the Justice Proof of Mass Publicity for Media Managers or Fraud Enforcement Proof against them. The Mass Claim Lead Taxation Case has Liability Order Denial Proof from Law Courts and Order Pretence Fraud Proof against Worcester Council.
7. On 1st August 2024 the F21YY087 Test will get either a Contempt Investigation Order + Stay or Refusal Fraud Appeal Grounds.
