Status Business Owner in Hereford

Complaint that Corruption by the State and Profession Authorities, Remedy Denial Frauds by the Law Courts and Protection Frauds by Cabinet, Opposition Leader Sir Keir Starmer and Parliament serviced a Ruin Fraud Conspiracy for the Protection Fraud Network against Citizen Ms Michelle Davies. The Ruin Fraud is a Sabotage Fraud against her Health Practice in Hereford

1. In 2024 Worcester Council Officers used Forgery + Perjury for a Council Tax Liability Fraud
2. Between 2021 and 2024 Worcester City Council used Taxation Frauds to finance West Mercia Police who used Budget Frauds to finance Crown Court Trial Frauds.

Brief Circumstances

1. The Forgery Proof + Perjury Proof + Ruin Fraud Conspiracy Proof is:
 - 1.1. The No Case Records Email at 12.53 on 25 March 2024 from Worcester Magistrates Court Officer Ms Naim Bas
 - 1.2. The Forged Council Tax Liability Order Certificate dated 12th March 2024 that bears a signature but does not whether it is by a Magistrate, Clerk or Officer,
 - 1.3. The Valid Due Process Pretence Frauds + Goods Seizure Threats + Bankruptcy Threats by Worcester City Council Revenues Team Leader Mr Phil Goodwin-Jones
2. The Pharmaceutical Industry bought Market Frauds for Drug Treatment against Other Treatment. One was creation of the General Osteopathic Council to manage Profession Governance Frauds against Registered Osteopaths. In 2000, Fraud Complaints in more than 200 Constituencies got a Corruption Debate + Investigation Commitment + Pending Investigation Adjournment + Investigation Denial Frauds + Protection Frauds that enabled Continuing Corruption by the General Osteopathic Council. The Corruption Debate was a Corruption Acknowledgement by Parliament that got Obvious Target Status for the General Osteopathic Council in any Corruption Remedy Process managed by the Coronation Oath Enforcement Authority. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Equity lawyer Mr Ellis and Queen Elizabeth used it to start a Corruption Remedy Process. It has continued ever since. The Patient Satisfaction Internet Publicity Prohibition was a Market Frauds for Market Competitors against Registered Osteopaths. A Fraud Complaint by Registered Osteopath Ms Davies motivated a Ruin Fraud Conspiracy by Corrupt Officers against her. They used Conflict Qualification Frauds for Complaint Investigation Frauds + Dismissal Frauds + Mental Unfitness Suspicion Frauds + Examination Demand Frauds + Pending Examination Suspension Frauds + Osteopath Misdescription Prosecution Frauds + Jurisdiction Trial Denial Frauds + Conviction Frauds + Disqualification Frauds + Mass Publicity Defamation Frauds. The Jurisdiction Trial Denial Frauds used Jurisdiction Trial Pretence Frauds for a Court Room Exclusion Fraud against the Jurisdiction Witness. It used Public Gallery Criminal Trespass by West Mercia Police for an Assault Framing Fraud + Arrest Fraud + Charge Fraud against the Public Gallery Witness until a Crown Court Audio Records Production Demand + Bail Surrender Refusal by him got a Total Collapse of the Prosecution Case.

Remedy Proposals

1. Corruption Claim + Contempt Investigation + Pending Investigation Enforcement Stay Application by Hereford Council against All Local Authorities and the Cabinet for All Constituents of Hereford Council
2. Corruption Claim Mass Publicity for Victim Identification
