Complaint Reasons

The Coronation Oath Enforcement Authority has Corruption Control Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority Responsibilities of Parliament. The Parliament Session Courts decides the Corruption Remedy Priorities for each Parliament Session. Remedy Sabotage Frauds by Opposition Leaders Sir Keir Starmer created the need for Mass Remedy Conditions in the Session Grant by the crown to him as Prime Minister. The Prisoner Mass Release is one. The Parliament Session Court needs Mass Claim Lead Case Offers as Integrity Tests to discover what publicity, if any, they get from Media Managers, and Remedy Tests of All Relevant Authorities. The Forgery + Perjury for the Council Tax Liability Fraud are excellent for the purpose. The Mass Claim needs a Claim Leader with Fee Remission Rights. Business Expense Reserves are a Fee Remission Disqualification for Citizen Ms Davies. Citizens Mr Katsiaounis has Fee Remission Rights but is 84 years old and Limited Case Management Capacity. Citizen Dr Spivack has Fee Remission Rights and can cope.
