 - 1.3. The Asset Freezing Frauds denied access to the funds in Barclays Bank sort code 20 02 62 +_ accounts 03906434 + 80390445
2. Corruption Remedy Test Co-operation using a
 - 2.1. Full Co-operation by Essex and Suffolk Water to get a 2022 002595 Revocation Order of the General Civil Restraint by the High Court for Prime Minister Mr Boris Johnson and Opposition leader Sir Keir Starmer that denies use of the Law Courts and is an Asset Freezing Fraud
 - 2.2. Full Co-operation by Essex and Suffolk Water getting a fraud Appeal 2023 00569 General Public of Importance Certificate from the Court of Appeal that the Supreme Court claims it needs to process Fraud Appeal 2023 0174
 - 2.3. Full Co-operation by Essex and Suffolk Water to remedy the Passport Denial Fraud by the Home Office that denies Money Laundering Compliance and has effect as a Financial Asset Freezing Frauds
 - 2.4. Full Co-operation by use of a Garnishee Order Consent with No Costs Conditions by the Equity Lawyer and the Sort Code 20 02 62 and Accounts 03906434 + 80390445 to get Garnishee Consent Orders for Essex and Suffolk Water against Barclays Bank with Full Disclosure by Essex and Suffolk Water at every stage of the process
 - 2.5. Full Co-operation by Essex and Suffolk Water identifying the Dividend Payments In that identify Other Frozen Assets
 - 2.6. Full Co-operation from Essex and Suffolk Water to remedy denial of the Inheritance Liability Certificate by HM Revenue & Customs that is a Freezing Fraud of All Assets the Intestacy Trusts and Endowment Trusts of the late Charles Sydney Ellis who are half owned by the Equity Lawyer who is his brother and he and his sister inherit as next of kin.
 - 2.7. Full Co-operation discovers how many customers of Essex and Suffolk Water are Victims of Similar Fact Asset Freezing Frauds
