1. The 2024 Parliament Session Integrity Test Cases by Citizens so far have got Issue Denial Fraud Proof against the Law Courts.
2. The Test Case Papers are Relevant Evidence for the Fraud Appeal 2024 001159 Bundle
3. The Investigation 01 YE 15441 23 got a Written Notice that Case Files and Audio Records are Fraud Conspiracy Proof against the State, Profession Authorities and Law Courts and Defence Evidence. It got a Recorded Interview Refusal and Immediate Reference of All Case papers by the Case Officer Mr Flanders up the ranks to Metropolitan Police Commissioner Sir Mark Rowley, and Carefully Time References by him to Prime Minister Sir Keir Starmer.
