

Priming Case Proposal

Premises: Round Tower Church + Graveyard + Car Par at Broomfield, Chelmsford

Reasons: Heritage Status for the Round Tower gets State Support for Fabric Maintenance
 The Clergy and Congregation want a Viable Conditions for Continued Services
 Viable Conditions need Facilities Expansion for Acceptable Activities
 Acceptable Activities are a Nursery School and Youth Club
 Suburban Location near Open Land that could be available for Sport Activities
 Conversion of the Cavity Space for shared use by the Church and Youth Club
 Location makes Crowd Funding a Viable Proposition for the Conversion Costs
 Expansion of the Church Hall for the Nursery School
 Nursery School and Youth Club need an Educator Skill Set
 Nursery + Youth Club + Church provide a Viable Living for the Educator Skill Set

Circumstances

Society needs Youth Clubs. Children need Support Services that become progressively more sophisticated. They need Advanced Support that enables maintenance of a good relation with authority until they achieve Mature Independence. Parents cannot do it all. Youth Clubs provided Advanced Support. They were Charity Services. They relied on Citizens for finance and management. A Citizen is anyone who uses Business management to service the Justice Priority.

The Politicians made a Dictator Governance Plan for Western Europe. It vested Remedy Power Monopoly in the State. It needed a Leadership Monopoly. It used Sabotage Frauds against anyone who was a Leadership Competitor. It classified the Citizen as a Leadership Competitor. Sabotage Frauds against the Citizen did Collateral Damage that included loss of Youth Clubs. In every Member State of the European Union the Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and manage Co-ordinated Corruption. They were Giant Leaches that made State Bankruptcy inevitable. Honourable Politicians needed to restore Just Governance. They needed a Giant Leach Destruction Plan. The Gnostic Christians made one. They called it the Equity Governance Recovery Plan. It changed the balance of power for the Citizen against the State.

In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Queen Elizabeth used it to deploy the Equity Governance Recovery Plan. It enabled the Parliament Sessions Court to start a Corruption Remedy Process. It has continued ever since. In 2024 the Parliament Sessions Court forced use of the Post Office Scandal and Health Scandals to get Mass Publicity for Corruption Exposure against the State up to Cabinet Level, Remedy Denial Frauds by the Law Courts, Mass Remedies by Parliament and Remedy Efforts of Honourable Individuals. It increased the Retirement Rate of Governing Majority MPs, denied a Credible Choice for Voters, split the Conservative values Vote and enabled a Minority Vote to get a Landslide Governing Majority for and enabled a Minority Vote led by Sir Keir Starmer in spite of Corruption Proof got against him as Director of Public Prosecutions and Opposition Leader. All of it got a Power Transfer for the Citizen against the State. The Youth Club Revival Project will cause more people to understand the Power Transfer and give them a chance to do something with it. It needs a Priming Case. The Round Tower is excellent for the purpose.
