The Best Advice is Mass Publicity that identifies Similar Fact Cases for Mass Claims

1. Supreme Court Fraud Appeal 2023 0174 of Equity Lawyer Mr Ellis, an Essex Resident, against the Cabinet awaits a Court of Appeal Certificate that the Court of Appeal 2023 000569 Case Frauds have General Public Importance.
 - 1.1. The Parliament Session Priority was Credibility Recovery for the Authorities. It needed Dismissal Executions against Top Judges by a United Parliament, Victim Identification and Case Remedies. Dismissal Failure was Protection Fraud Proof against the Cabinet. The Default Penalty of a Dismissal Decision against Prime Minister Mr Johnson. Dismissal Help Requests by Governing Majority MPs got Hep Refusals that were Protection fraud Proof against Opposition Leader Sir Keir Starmer. He had Court Fraud Joint Liability with Top Judges. He used the office of Director of Public Prosecutions to provide Protection Frauds for Celebrity Paedophiles and many others. He used the office to get Imprisonment Frauds against Innocent Victims and Release Denial Fraud Blackmail to extort False Guilt Admissions by thousands of Political Prisoners. All of the Original Citizen Papers on the Parliament Session File kept by the Director of Public Prosecutions have Finger Print Proof that is Personal Responsibility Proof against Sir Keir Starmer from December 2011 until he left office in 2013. Other cases got Personal Responsibility Proof against him. The 17 Years' Imprisonment Fraud Case got Release Denial Fraud Conspiracy Proof against Sir Keir Starmer as Director of Public Prosecutions and Opposition Leader. The Release Refusal Reason of Justice Secretary Mr Raab was that the Release Costs included Imprisonment Fraud Damages that exceeded the Future Imprisonment Fraud Costs.
 - 1.2. The Protection Fraud Proof against Opposition Leader Sir Keir Starmer created the need for Forced Mass Remedies by Parliament. It needed a case that had Rights Definition Fraud Proof, Breach Liability Fraud Proof and Imprisonment Fraud Proof for an Innocent Victim against Law Court Judges.
 - 1.3. Integrity Test motivated the use Restraint Powers for Rights Definition Frauds, Breach Liability Finding Frauds + Suspended Sentence Imprisonment Frauds by Top Judges against Equity Lawyer Mr Ellis.

Parliament Session Grants from the Crown used Enforcement Prohibitions to get Continuing Services from the Equity Lawyer until they needed the Imprisonment Fraud Enforcement Proof for Mass Remedies. The Contempt Claims and Fraud Appeals of the Equity Lawyer got Fraud Conspiracy Proof against Prime Minister Mr Johnson, Opposition Leader Sir Keir Starmer and Top Judges. In June 2022 By Election Defeats got a Forced Leadership Resignation by Prime Minister Mr Johnson. In September 2022 the Parliament Sessions Court forced the Cabinet to get issue of Contempt Claim 2022 003098. It got completion of the Fraud Proof Set against the High Court needed for Mass Remedies. The Fraud Appeal 2023 000569 and 0174 of the Equity Lawyer got completion of it against the Court of Appeal and Supreme Court. The Parliament Sessions Court forced use of the Post Office Scandal to get Corruption Exposure against the Sate to Cabinet Level, Remedy Denial Frauds by the Law Courts, Remedy Efforts by Honourable Individuals and Mass Remedies by Parliament.

2. Court of Appeal Protection Denial Fraud Appeal 2023 0001159

2.1. A series of Fraud Cases enabled Citizen Mr Akwasi Nkrumah to get Seal Ink on Original Documents and Computer Records that were Record Fraud Proof for Corruption Investigations of the Law Courts. Top Judges made an Investigation Sabotage Plan. It needed Records Theft + Records Destruction. In September 2020 the Citizen attended a Court Hearing, produced an original Document from a Big Bag. An Event Report by a Court Officer got a Big Bag Snatch Theft Order by a Top Judge that and Bag Snatch Theft as the Citizen left Seven Kings Station on the Return Journey.

2.2. On 12th June 2021 in Southend on Sea a Motor Trial Fraud Conspiracy used a Public Gallery Clearance Order Fraud by a Magistrates Court Judge got Public Gallery Criminal Trespass + Assault Pretence Fraud + Assault Arrest Fraud + Custody Fraud + Investigation Fraud + Charge Fraud + Bail Conditions Fraud by Essex Police against Citizen Mr Akwasi Nkrumah + Prosecution Fraud by the Crown Prosecutors. The Plea Hearing Report on 5th July 2021 by Equity Lawyer Mr Ellis got a Confidence Collapse + Fraud Completion Case Transfer + Committal Fraud from the Magistrates Court to the Crown Court + Fraud Completion Confidence Collapse by more than 50 Crown Court Judges evidenced by Fraud Completion Case Transfer from St Albans to Chelmsford then Basildon and then Snaresbrook where it got Public Gallery Rights Trial Case Reference 2023 1180 and in May 2024 an Unexplained Adjournment Order to 2026

2.3. The Investigation Sabotage Plan needed Computer Theft + Computer Destruction. Top Judges procured an Eviction Fraud + Computer Theft by a Private Landlord. A Theft Complaint + Good Recovery Request got Framing Fraud 2022 0043, Case Refusals by 100 Crown Prosecutors and an Adjournment Order to 2026

3. Chancery Court Trust Fraud Case PT 2024 000393 of Father Mr Sham Pal Sood v Son Mr Vischal Sood.

3.1. Mr Sham Pal Sood helped his 2 Older Sons get employment in the Financial Services. They used Client Wealth Details to identify Ruin Fraud Targets and sold the Target Information to Top Judges.

3.2. The Father did not know about the Criminal Activities of the Sons. He funded Property Purchasers for a Family Trust and gave them Trustee Status. They used it for Trust Frauds that caused £2,000,000 Asset Losses + Additional Revenue Losses for the Father. Legal Action got Fraud Conspiracy Proof for the Father against the Sons, Regulated Lawyers and the Law Courts. In 2024 Corruption Exposure got a Confidence Collapse and issue of Trust Fraud Case PT 2024 000393 and Test Use Authority from the Father.
