REASONS

Trust Claim PT 2024 000393 has Special Value to the Parliament Sessions Court. It is very convenient that Regulated Lawyers got the Case Reference. All of the Integrity Test Cases managed by Equity lawyer Mr Ellis got Issue Denial Fraud Proof against the Law Courts. He has End Stage Kidney Failure. Dialysis Treatment gives him 1/12th the Blood Cleaning Service of that provided by Health Kidneys. What a Healthy Person relies on for 12 hours has to last him all week. Mr Sham Pal Sood is a Good Man but a Nightmare Client. The Equity Lawyer did not have the energy to come with him and all of the others. He paid £4,000 to Regulated Lawyers. They produced the Claim Form and Particulars dated 2nd May 2024. They give a Sufficient History to get the Case Reference. Full Details would have added to the Issue Denial Fraud Proof against the Law Courts.

Defendant Mr Vischall Sood is one of the Financial Service Professionals who identified Ruin Fraud Targets and sold Client Wealth Details to the Ruin Fraud Managers. It got Job Profits and Protection Frauds for the Trustee Son from Top Judges. The Father gave use of his cases Integrity Tests of the Authorities. They got Corruption Proof against the Trustee Son, Representatives, State, Profession Authorities and Law Courts. The Parliament Sessions Court used All Test Results, including those of the Father, to force the Post Office Scandal and Health Scandals that got Mass Publicity for Corruption Exposure that broke the Conservative Governing Majority. It got a Confidence Collapse, Recorded Interview Refusal and Case References up the Command Chain to Metropolitan Police Commissioner Sir Mark Rowley. The only thing he can do is make Case References Reports to the Home Secretary and Prime Minister. When he took office he made a Corruption Remedy Commitment that got Mass Publicity. The process makes him angry. Unhappy Images of the Metropolitan Police Commissioner on Report Visits are part of the preparations by Media Managers for the Dismissal Process against the Prime Minister. Case Officer Ms Ballam did well but needs Support Services to cope with the rest of the process.
