The Case Headings get Admissible Evidence Status for Case Papers in the Parliament Sessions Court

Best Advice is an Exposure Plan by Journalists of Censorship + Propaganda Frauds for the Protection Fraud Network.

1. The Network had a Costs Control Policy. It used Paedophile Entrapment and Paedophile Framing Frauds to get Exposure Blackmail Victims. It used Appointment Frauds to Key Offices for the Exposure Blackmail Victims that got Reliable Fraud Services at No Profit Share Cost. The Key Appointees needed Protection Fraud Reassurance. They were given Protection Frauds for Celebrity Paedophiles.
2. In 2003 events that functioned as a Protection Fraud Test. A scandal exposed Sex Crimes for 18 years by a School Headmaster. The victims included the twin sons of the Deputy Head Mistress. She was angry and a Talented Communicator. Media Managers could not ignore the story or her. A Non-Custodial Sentence for him got a Sentence Appeal Campaign by her, Mass Publicity from Media Managers, Personal Interviews for her with the Attorney General and Lord Chancellor, a Sentence Appeal by the State and a Prison Sentence for him.
3. Investigation is needed to discover what influence, if any, it had on the Top BBC Presenter Appointment in 2003 for Journalist Mr Huw Edwards. He who was in active service until 2023 and resigned in 2024.
4. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against the European Leaders. The Lawful Business of British Citizens made inevitable exposure of the Election Frauds. The European Leaders an Election Fraud Concealment Plan. It Sabotage Frauds against the Lawful Business. It used Imprisonment Frauds by the Dutch Authorities against the Business Managers. It used an Extradition Fraud against a British Business Manager and Imprisonment Frauds against him and a Dutch Business Manager. Everything that could go wrong for the European Leaders did go wrong. The 1st Extradition Fraud discovered that Top Police, Top Customs and Top Judges were the Top Drug Dealers. The 2nd Extradition Fraud needed Innocence Evidence Concealment Frauds by the UK Authorities before completion of the Dutch Authorities. It needed Immunity Frauds from European Leaders in exchange for Extradition Fraud Services by the Top Drug Dealers. It got a Drug Crime Profit Share for Prime Minister Mr Blair. It got Criminal Conspiracy Proof that enabled Equity Lawyer Mr Ellis and Queen Elizabeth to revive the Coronation Oath Enforcement Authority and start a Corruption Remedy Process.
5. Investigation is needed to discover what influence the Corruption Remedy Process had on the decisions that in 2004 got a Publicity Restraint Fraud by the State against the Deputy Head Mistress.
6. In 2006 the Remedy Process got a Forced 10 Months' Resignation Notice from Prime Minister Mr Blair. His Retirement Arrangements included Drug Crime Profit Shares for Cabinet Ministers. They had Keir Starmer appointed the Director of Public Prosecutions so that he could manage Protection Frauds for them.
7. There were a series of Ruin Frauds against the Deputy Head Mistress and her husband.
8. The Remedy Process used the 2 ½ Year Parliament Session from 2010 to 2012 for a Corruption Investigation of the Law Courts that got Fraud Proof against All Authorities. The Last Case got Finger Print on Case Papers that was Personal Guilt Proof against Sir Keir Starmer who was the Director of Public Prosecutions.
9. Investigation is needed into what influence, if any, Protection Frauds by Keir Starmer and Huw Edwards for Celebrity Paedophiles had on a Sentence Deal. Huw Edwards got No Prison Publicity for Paedophile Offenders + £40,000 Salary Increase and Keir Starmer got Silence Promises.
