No Offence Intended Notice from Equity Lawyer to Media Managers

The Common Law makes the Remedy Obligations proportionate the Remedy Powers.

The Remedy Process will make service of the Coronation Oath Enforcement Authority the Key Qualification for All Professions and Profession Disqualification the Default Penalty.

Polite Request that Media Managers consider Responsibility Apportionment between themselves. They need to service the entire spectrum of Audience Interest from Petty Personal Interest to Major Public Dangers.

Audience Interest Classification Request and News Coverage for Sample Cases of Equity Lawyer Mr Ellis:

1. In 2004 a Ruin Fraud Conspiracy managed Prime Minister Mr Blair against the Equity Lawyer used Asset Freezing Frauds and Asset Thefts. They included Account Frauds that were Unjust Enrichment Frauds for Barclays Bank and Dividend Denial Frauds + Shareholding Denial Pretence Frauds that were Unjust Enrichment Frauds for Publicly Quoted Companies. The Ruin Frauds included Health Service Frauds. IN March 2019 the Equity Lawyer who is NHS Patient 6328556020 changed from a Bright GP to a Hainault GP.
2. In 2022 an Eye Sight Test got an Early Cataract Warning.
3. In 2023 the Corruption Remedy Process motivated Health Records Destruction by the Protection Fraud Network. A De-Registration Fraud by the Hainault GP used knowledge the Equity Lawyer did not have a passport for a Passport Identity Proof Service Requirement and a Passport Proof Failure for De-Registration. The NHS System had No GP Details but identified a Brighton NHS Trust that was not used after March 2019
4. In 2024 an Eye Sight Test got a Cataract Case Reference the Brighton NHS Trust.
5. In 2024 the Passport Application PEX 530 360 8791 of the Equity Lawyer got Process Refusal Proof against the Home Office. The Renal Team Manager was responsible for the Dialysis Treatment that saved the Patient's life three times a week for more than 4 years from April 2020. He agreed to be Identity Witness. The Passport Application System accepted his Witness Details. The Identity Verification Evidence from him got a Verification Failure Finding + No Given Reason from the Passport Office. The Round Tower Vicar agreed to be an Identity Witness. Use of the Vicar Details for Identity Witness Details got Entry Denial Fraud Proof and an Identity Verification Failure Reason for a Timed Out Application Dismissal Fraud by the Passport Office.
6. On 12th July 2024 the Equity Lawyer, who is NHS Patient 6328556020, made a Registration Application that got No Response from Chelmer Medical Practice and Tennyson House GP Surgery.
7. In 2024 TV Licence 6641791609 Fee Payment Demands by the BBC and Water Account Payment Demands by Essex and Suffolk Water got a Settlement Offer from the Equity Lawyer conditional upon Full Co-operation getting a Garnishee Order against Barclays Bank Accounts. It needed an Email Addresses for the Settlement Offers that the Payment Demands and Internet Searches did not provide.
