#### Circumstances

The Crime Complaint Procedure evidences a Priority Decision for the Status Details about the Complainant and Complainee against the Crime Event Facts and Support Evidence.

Flittabus Community Transport Ltd provides Bus Services that rely on Reserved Parking at Bus Stops. At 10.25 on 6<sup>th</sup> August 2024 an Asian British Man aged 40 to 50 was sat in the driving seat of the black sedan vehicle registration EX 14 5XL. It occupied the Bus Stop Reserved Parking at the Tesco Supermarket in Coniston Road, Flitwick, Bedfordshire.

The Route 140 Bus arrived. Repeat Horn Sounding was ignored by the Car Driver. The Bus Driver got out of the bus, approached the car and asked the Car Driver to move. It got an Aggressive Refusal by the Car Driver. The Bus Driver withdrew. Dr Spivack was a Bus Passenger who witnessed the events. She got off the bus, approached the Car Driver and asked him to vacate the Reserved Parking. It got an Aggressive Hostile Threatening Response from the Car Driver. The event ended about 10.30.

A Crime Complaint Offer by Citizen Dr Spivack got Grateful Acceptance by the Bus Driver because he did not have the time.

On 8<sup>th</sup> August 2024 the Crime Complaint by Dr Spivack got Reference 40/37707/24.

On 16<sup>th</sup> August 2024 the absence of a Video Record was given for an Insufficient Evidence Reason for a No Further Action Decision. It raises Investigation Fraud Suspicions against Bedford Police.

#### Similar Fact Evidence

In December 2023 a Criminal Complaint got an Arrest + Risk Warning against No Disclosure of Defence Evidence by the Metropolitan Police and Oral Notice that the Casino Video Records were Defence Evidence for Mr Katsiaounis. It got a 3 Months Investigation Delay and a Bail Appointment for 21<sup>st</sup> March 2024 with Bail Conditions that were a Defence Evidence Access Prohibition. A Bail Conditions Appeal + Evidence Production Application dated 24<sup>th</sup> February 2024 got Process Denial Fraud Proof against the State Appointed Defender, Metropolitan Police and Magistrates Court. Email Service at 13.15 gave Written Notice that Court Fraud Proof was Defence Evidence. The Bail Return Appointment at 16.00 that day got an Appearance Failure by the Case Officer and a Pretence Fraud Conspiracy by the Defender and Case Officer of a Bail Extension Decision made the day before. An Interested Party Status Application dated 24<sup>th</sup> April 2024 by Equity Lawyer Mr Ellis and Mr Andreas Theodorou got Process Denial Fraud Proof against the Defender, Police and Magistrates Court. An Investigation 01 YE 15441 23 Fraud Review Claim dated 29<sup>th</sup> May 2024 by Mr Katsiaounis got Process Denial Fraud Proof against the Defender, Police, Cabinet and Political Party Leaders. The Bail Return Appointment on 21<sup>st</sup> June 2024 got an Appearance Failure by the Case Officer and Repeat Bail Extension. The Bail Surrender Refusal Notice pending Fraud Remedies Notice dated 5<sup>th</sup> July 2024 got No Response from the Case Officer. The Additional Evidence Offer + Taxation Fraud Complaint dated 2<sup>nd</sup> August 2024 by Ms Michelle Davies, Mr Katsiaounis and Dr Spivack with Email Filing at 17.17 on 5<sup>th</sup> August 2024 by Equity Lawyer Mr Ellis got No Response from Case Officer Mr Flanders. All of it is Protection Fraud Proof for Citizen and People against the State, Law Courts, and Cabinet.

Because the reason given by Bedfordshire Police for the decision to take no further action re the incident on 6 July 2024 is the absence of a CCTV Record yet in 2006 PC 5467 Elliot reported to the General Osteopathic Council (GOsC) that I was "purse-pulling" and there was no CTV recording and no witnesses either. This resulted in loss of my career and livelihood. Therefore there is one standard for one person and a different standard for another. A CCTV Record is required to investigate and convict an Asian but none is required to convict a White person. More than this - on 14 January 2006 I opened my practice out of hours to provide an emergency triage to someone I had been led to believe was in mortal danger - they told me they had already been to the GP and to Casualty. My practice was closed

for the weekend and I was not under any obligation to provide an appointment out of hours. In fact I am not under any obligation to offer anyone an appointment at any time - it is solely at my discretion as to whether I grant someone an appointment. However under laws pertaining to First Aid and medical emergencies I had been advised in writing that I have a legal duty to step in otherwise I can be charged with criminal negligence. The intention was to triage for meningitis, encephalitis or subarachnoid haemorrhage and then refer to Accident & Emergency if necessary. I was not charging a fee for doing this but PC 5467 Elliot told the GOSc I was "purse-pulling" without my knowledge and without a recorded interview and without providing me with a lawyer and without Trial. The people I had acted to help were uncooperative with the Triage, became aggressive and violent and at least one of them was under the influence of a Class A drug. Lucy Greco assaulted me causing permanent damage to my cervical spine for which I have received no Criminal Injuries Compensation. Contrast this with the case of Jane Fruisciance a Nurse who lives in Flitwick who was given the Local Policing Commander's Certificate of Merit for talking a man out of committing suicide on a bridge in Bedford - report in Bedfordshire Times & Citizen 14 February 2013 "Recognition for Nurse who helped save man's life". No discrimination there then ? Osteopathy is derived from a theological premise rooted in Native American Indian culture so there is a racist / religious discrimination motive here.

Dear Bedfordshire Police,

I noticed this article in the news a few days ago:

Three police officers are assaulted at Manchester Airport after they are set upon as they investigated an abandoned car

Greater Manchester Police were inspecting the car, which is uninsured, after it was left in an unauthorised space at the airport's Terminal Two on Wednesday morning.
