Contempt Remedy Preliminary Proposals of Citizen Mr Katsiaounis

15th September 2024

1. Agency Representation Monopoly Forfeit for the Citizen against Registered Professionals and Profession Authorities for the Justice Management Reason
2. Unregistered Agent Representation Right for the Citizen against the State and Profession Authorities
3. Discovery Order for the Citizen against the Complaint Supervision Officers, Investigation Officer, State Approved Defender, Defence Case Supervision Officer, Defence Case Management Officer that they do within 7 days file and serve Statements that explain what each of them knows about the process, and identifies the process records of:
 - 3.1. the Complainant, Complaint Evidence Identification, Complaint Evidence Seizure, Before Arrest Events, Arrest Event, After Arrest Events, Custody Reception, State Approved Defence Representation, 1st Investigation Interview, After Interview Custody, Complaint and Defence Evidence Identification, Complaint and Defence Evidence Seizure, Bail Conditions Decision Process, 1st Bail Event, 2nd Interview Failure, Bail Appeal and Contempt Remedy Application dated 24th January 2024 of the Complainee, Bail Conditions Revocation Application and Contempt Remedy Application dated 24th April 2024 of the 2 Maternal Grand Sons and Equity Lawyer, Investigation Fraud Judicial Review dated 29th May 2024 of the Complainee, 2nd Interview Refusal, 2nd Bail Event, 3rd Bail Event and Bail Extension Application
 - 3.2. the Case Management Capacity Assessments of the Complainant and the Complainee at the time of the Complaint Events and the Investigation Events
4. Order Compliance + Further Directions Hearing at noon on October 2024
Justice Management Reason

The Top Corruption Controls are the Coronation Oath for Equity Governance using the Common Law, the Corruption Remedy Priorities for each Parliament Session that are decided by the Coronation Oath Enforcement Authority and General Elections that change Governing Majorities and prevent Power Concentration in Unrepresentative Minorities. The Coronation Oath Enforcement Authority has Corruption Control Jurisdictions that control Parliament Session Powers. They use the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim. They manage the Profession Authority Responsibilities of Parliament. The Citizen has Investigation Jurisdiction. It is the power to give a Confidentiality Waiver, Privilege Waiver and Case Management Authority for use of the truth, whole truth and nothing but the truth for Integrity Tests of the Authorities. The Equity Lawyer has Test Management Jurisdiction. It is the power to provide Integrity Judgment Services that get Justice Proof for Honourable Officers or Corruption Proof against the State and Remedy Denial Fraud Proof against the Law Courts. The Crown has Prosecution Jurisdiction. It is the power to use Integrity Test Proof Sets for Trial Orders of Corruption Cases against the State and Unfitness Cases against Officers and Authorities by the Parliament Sessions Court. The 2 Lord Archbishops serve as Trial Lawyers, one for the Trial Court and the other for the Appeal Court. The 24 Lord Bishops provide up to 12 Trial Jurors and up to 12 others as Appeal Jurors. When they are busy they split into 2 Trial Juries of 8 and 1 Appeal Jury of 8. The Corruption Remedy proof Standard eliminates the need for Witness Attendance, Credibility Findings and Case Presentation by the Crown. It enables Trial Orders of the Crown to get a Trial Verdict in 7 days and an Appeal Decision in 10 days. The Dictator Governance Plan for Western Europe vested Corruption Remedy Monopoly in the State. In the UK it needed dissolution of the Coronation Oath Enforcement Authority. Dissolution Advice from the Cabinet got a Coronation Oath Release Condition from the Queen Elizabeth. It needed a Reference Majority for Dictator Governance against Equity Governance. Everyone knew that the Referenda Process would be an Education Process that ended with a choice between Dictator Powers for the State or Corruption Control Powers for the Voter and a Landslide Rejection of Dictator Governance. Dictator Politicians dare not hold Governance Referenda. They made an Equity Governance Sabotage Plan. They used Judgment Service Penalty Frauds against Qualified Lawyers to get Admissible Evidence Denial Frauds and a Dormancy Period for the Coronation Oath Enforcement Authority. Censorship Frauds denied any mention of the Coronation Oath Enforcement Authority in the Academic Curricula and Profession Qualification Curricula. The intent was that everyone would forget how to service it and then that it existed and All Active Service Experience of the Coronation Oath Enforcement Authority would die with Queen Elizabeth. The Dictator Plan created Profession Authorities to service the Remedy Monopoly of the State. In every Member State of the European Union Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and manage Co-ordinated Corruption. They got control of the Profession Authorities. The Equity Governance Recovery Plan kept the Coronation Oath Enforcement Authority ready for Revival Conditions. They needed Criminal Conspiracy Proof against a serving Prime Minister and a Reliable Supply of Admissible Evidence for Authority Revival and a Corruption Remedy Process. In 2004 they got Revival Conditions. In 2024 the Remedy Process got Mass Remedies. Investigation 01 YE 15441 23 is a Remedy Process Test Case.
