### **Top Level Contempt Penalty Warning from the Coronation Oath Enforcement Authority**

1. The 2024 Parliament Session Remedy Priority is Credibility Recovery for the Authorities. Remedy Co-operation Denial Frauds by Cabinets and Parliaments since Prime Minister Mrs May took office in July 2016 created the need for Forced Remedies. The Parliament Sessions Court cannot ignore Corruption Proof and Remedy Denial Fraud Proof got against Prime Minister Sir Keir Starmer when he was Director of Public Prosecutions and Opposition Leader. In 2023 as Opposition Leader he serviced Finding Pronouncements of the Imprisonment Fraud Finding + Protection Fraud Finding + Enforcement Fraud Finding + Unfit Judiciary Findings. In 2024 he is servicing the Corruption Remedy Requirement for 20,000 Imprisonment Fraud Releases and committing Release Priority Frauds for Guilty Criminal against Imprisonment Fraud Victims and True Reason Concealment Frauds and False Reasons Misrepresentation Frauds by concealing the Imprisonment Fraud Reason, his Personal Liability for Imprisonment Fraud since he took office as Director of Public Prosecutions, and Release Delay Fraud Liability since he took office as Opposition Leader. The 2024 Session Priority Test Cases have got Fraud Proof against the State and Remedy Denial Fraud Proof against the Law Courts with All Test Cases getting Personal Joint Liability for All Cabinet Members. A Criminal Investigation has been particularly useful getting Joint Liability Proof.
2. Unusual Events on 19<sup>th</sup> December 2023 got a Rape Complaint by a 19 year old woman against an 83 year old man and Metropolitan Investigation 01 YE 15441 23 and an Arrest on 21<sup>st</sup> December 2023. The 1<sup>st</sup> Recorded Interview of the Complainee with a State Approved Defender identified Casino Video Records as Self-Management Capacity Evidence for both the Complainant and the Complainee and Incredibility Evidence for the Complainee against the Complainant. It discovered that the Octogenarian Complainee had Social Skills but Limited Capacity for Complex Cases. It discovered that Case Delays and Natural Aging were a Very Bad Risk of memory Loss and Case Management Incapacity. The 3 Months Bail Return Date is Incapacity Exploitation Fraud Proof against the Case Investigator. The Fraud Remedy Action Failure is Fraud Conspiracy Proof against the State Approved Defender and the Investigator. A Bail Conditions Appeal + Contempt Remedy Application dated 24<sup>th</sup> January 2024 got Process Denial Fraud Proof against the Defender, Investigator and Magistrates Court. The Written Notice dated 20<sup>th</sup> March 2024 that Defence Evidence was the Corruption Proof against the State and Profession Authorities, Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof against Cabinets and Parliaments, and Email Service of it 2 hours 45 minutes before the 1<sup>st</sup> Bail Return Time on 21<sup>st</sup> March 2024 got an Appearance Failure by the State Approved Defender and Investigator, and a Backdated Bail Extension Forgery that is Fraud Conspiracy Proof against the Defender and Investigator. The Case Reference Best Advice dated 22<sup>nd</sup> March 2024 got Case References from Investigator via all superiors to the Metropolitan Police Commissioner, Sir Mark Rowley, Home Secretary, MP Ms Yvette Cooper, and Prime Minister, Sir Keir Starmer, or Case Reference Failures that are Supervision Failure Proof + Contempt Immunity Fraud against All Superiors. The Contempt Remedy Application of Equity Lawyer Mr Ellis and 2 Grand Sons, and the Investigation fraud Judicial Review dated 29<sup>th</sup> May 2024 got Process Denial Fraud Proof against the State Approved Defender, Magistrates Court and High Court Administrative Division. The 2<sup>nd</sup> Bail Return Date got an Appearance Failure by the Defender and Investigator. Bail Appearance Refusal Notice dated 5<sup>th</sup> July 2024 from the Citizen. The Bail Extension Application got Fraud Conspiracy Proof against the Investigator and Magistrate Court. The Case References or Supervision Failures are Fraud Joint Liability Proof against All Cabinet Members. The Parliament Sessions Court cannot ignore it.

Courts, Remedy Efforts by Honourable Individuals and Mass Remedies by Parliament. It got an increase in the Retirement Rate of Governing Majority MPs and a Split Conservative Values Vote that enabled a Minority Vote to get a Landslide Majority of Novice MPs and the Premier Office for Sir Keir Starmer.

5. The 2024 Parliament Session is the first in the 335 years since the Glorious Revolution that starts with Corruption Proof and Protection Fraud got against the Prime Minister when he had State Office and was Opposition Leader. In these circumstances, Test Cases force the choice between Just Remedies or Enforcement Frauds that get Joint Personal Liability for State Frauds, Profession Authority Frauds and Court Frauds before the Protection Frauds.
6. The Rape Investigation 01 YE 15441 23 was ideal for the purpose. Accused Citizen Mr Katsiaounis gave an Integrity Test Case Use Authority to the Coronation Oath Enforcement Authority. The Test used Written Production Demands for Defence Evidence. It is Official Records got in many cases. It is Corruption Proof against the State and Profession Authorities, Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof against Cabinets and Parliament.
7. The Rape Investigation 01 YE 15441 23 Case Officer, all Supervision Officers, Metropolitan Police Commissioner Sir Mart Rowley, Home Secretary, Prime Minister and House of Commons Speaker needed to avoid an Investigation Interview or Court Hearing that got an Audio Record of Production Demands for Corruption Proof as Defence Evidence, or Demand Failures that are Criminal Conspiracy Proof against the State Approved Defender and Investigator. They used Interview Denial Frauds and Bail Extension Frauds
8. The Trust Claim B01B0837 + PT 2024 000393 have a B01B0837 Hearing Notice for 27<sup>th</sup> September 2024. The Father helped his sons get employment as Financial Service Agents. They identified Ruin Fraud Targets and sold the Client Wealth details to Top Judges. The Father did not know about their Criminal Activities. He founded a Family Trust and appointed them Estate Trustees. They committed Trust Frauds that did more than more than £2,000,000 Damage to their Father. Legal Action got Order Breach Contempt Fraud Proof against them and Contempt Immunity Fraud Proof against Law Court Judges. The B01B0837 Hearing on 27<sup>th</sup> September 2024 will get either Hearing Denial Fraud Proof against Top Judges with Joint Liability for All Cabinet Members or an Audio Record of Contempt Remedy Orders for the Father or Enforcement Frauds that get Joint Liability for All Cabinet Members.
9. Housing Estate Maintenance Account Claim K8DE4Y44 has a Hearing Notice for 4<sup>th</sup> October 2024. The Private Owner of a Long Leasehold Flat noticed Scaffolding Charges for No Works and Insurance Premium Charges 5 time the Internet Rate. Legal Action by him got Corruption Proof against the Metropolitan Police, Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof against the Cabinets of Mrs May and Parliaments. In 2019 it got a Forced Resignation from her and a Forced General before the year end. The Money Launderers and Top Judges made a Corruption Claim Deterrent Plan. Prime Minister Mr Johnson and Dismissal failures that were Protection Fraud Proof against Opposition Leader Sir Keir Starmer and Parliament. 10. The Bail Extension Fraud Appeal in the Crown Court and the Remedy Action in the High Court will get either Hearing Denial Fraud Proof against Top Judges with Joint Liability for All Cabinet Members or an Audio Record of Contempt Remedy Orders for Citizen Mr Katsiaounis or Enforcement Frauds that get Joint Liability for All Cabinet Members.
11. Contempt Investigation Orders will need Conflict Disqualification Investigations of everyone who has Remedy Powers. The Contempt Investigators need Advanced Notice that:
  - 11.1. In 2000, Osteopath Governance Frauds got a Corruption Debate, Investigation Commitment from Health Minister MP Ms Yvette Cooper. Investigation Denial Frauds got Protection Frauds for Profession Governance Frauds ever since. They got Honourable Resignation Refusal Proof that is Personal Liability Proof against from MP Ms Cooper who is now Home Secretary.
  - 11.2. Many cases got Corruption Proof against MP Sir Keir Starmer as State Prosecutor, Opposition Leader and Prime Minister. The Test Results add to the Corruption Proof, Remedy Denial Fraud Proof and Protection Fraud Proof.
12. The Parliament Session Court cannot ignore the State Frauds, Profession Authority Frauds and Court Frauds with Joint Liability for All Cabinet Members, or the inevitable Protection Fraud Proof against the Cabinet and Parliament. The Remedy Proposals include the choice for Parliament to provide a Coalition Remedy Government led by MP Mr Miliband, who has the benefit of Remedy Co-operation Proof got when he was Opposition Leader, or a Session Refusal and Forced General with Mass Publicity for the Corruption Proof, Remedy Denial Fraud Proof and Protection Fraud Proof. The Major Opposition Party is not prepared to present a Credible Choice in a Forced General Election, but some of the Other Opposition Parties have the benefit of a Credibility Presumption with No Rebuttal Proof Positive.
