1. Trust Cases Finding + Claimant Status Finding + Defendant Status Finding + Case Consolidation Entitlement Finding for the Beneficiary Father, Mrs Sham Sood and the Trustee Son, Mr Vishal Sood.
2. County Court Trust Claim B01B0837 Order Breach Contempt Fraud Allegation Finding + Contempt Immunity Fraud Allegation Finding for the Father against the Son, County Court, High Court and Court of Appeal

#### Reasons

1. From 2004 to date Equity Lawyer Mr Edward Ellis has recruited Citizens and managed Integrity test for the Coronation Oath Enforcement Authority. Law Courts used Restraint Order in efforts to stop him doing so.
2. The Father, Mr Sham Pal Sood has status as Trust Founder and Trust Beneficiary. His two Older Sons, Mr Vishal Sood and Mr Ritesh Sood have status as Estate Trustees in Separate Trusts. The Trustee Sons are Financial Service Agents. On the evidence available they used Client Wealth Details to identify Ruin Fraud Targets and sold it to the Protection Fraud Network. Crime Partnerships of Bankers, Lawyers and Judges used it for Ruin Frauds against Victims. It enabled the Trustee Sons to commit Trust Frauds against the Father and get Protection Frauds from the Law Courts. The Case Histories validate Case Consolidations and use of the words Father and Son to identify the Parties, and in the event of consolidation of all cases use of Son Vishal and Son Ritesh to distinguish between them.
3. The Father claims he authorised the Equity Lawyer to use the Trust Cases for Integrity Tests of the Authorities. They got Corruption Proof against the State and Remedy Denial Fraud Proof against the Law Courts Records.
4. In 2024 the Parliament Sessions Court used the Fraud Proof Sets got by the Equity Lawyer to force use of the Post Office Scandal and Health Scandals to get Mass Publicity for Corruption Proof against the State and Profession Authorities, Remedy Denial Frauds by the Law Courts and Protection Frauds by Cabinets and Parliament. It got an increase in the Retirement Rate of Governing Majority MPs, an Incredible Choice, Split Conservative Values Vote that enabled a Minority Vote to get a Landslide Majority for the Cabinet.
5. Corruption Investigations and Corruption Exposure start with Original Crimes or End Bribery, or anywhere between them. The Parliament Sessions Court forced Mass Publicity for Bribery Questions of the Cabinet in the 12<sup>th</sup> week after their Landslide Victory. The B01B0837 + PT 2024 000393 Contempt Investigations will use Trust Frauds and Court Frauds against the Father for Bribery Enquiries of Top Judges and the Cabinet.
