Best Advice + Immunity Negotiation Offer + Presentation Advice for Commissioner Rank Police 7<sup>th</sup> October 2024

Sir Mark,

The Best Advice is Crime Reporting to a Parliament Committee by Commissioner Rank Police against the Cabinet.

The Crime Complain dated 7<sup>th</sup> October 2024 is designed for the purpose. It is Additional Evidence for Investigation 01 YE 15441 23. If that gets Just remedies there will be no need to get a Separate Complaint Reference.

Immunity Negotiation Offer is to get Full Disclosure by All Police Officers who helped to get the Criminal Conspiracy Proof against the Cabinet.

The Presentation Advice is:

1. Start with the Crime Complaint dated 7<sup>th</sup> October 2024
2. Present the Remedy Co-operation Proof for Police Officers got in earlier stages of the Corruption Remedy Process.
  - 2.1. In 2007 Metropolitan Police Commissioner Sir Ian Blair knew the Bribery Unjust Enrichment of Top State Officers and top Judges used a Drug Dealer used a False Identity, a One Man Company, a Nat West Bank Mortgage to buy a Derelict Trading Estate in North West Kent, and Drug Crime Profits for Estate Refurbishment. There was nothing he could do about it. In November 2007, Honest Officers by passed the Scanning Process, placed Original Papers on the desk of Sir Ian Blair and thereby demonstrated they would the Equity Lawyer to service the Corruption Remedy Process. It gave Sir Ian the confidence to use an Honest Officer in Essex Police to prepare the Money Laundering Proof Set and a Known Contact to deliver it to Equity Lawyer Mr Ellis. He got Protection Fraud Proof against Top Banker Sir Fred Goodwin and Assistant Commissioner Mr John Yates. Bank Fraud Case 5920 got Protection Fraud Proof against Top Judges. It prepared for the Bank Fraud Liability Finding, £8 Billion Damages Fund and Forced Victim Identification. The Knighthood Forfeiture against Fred Goodwin was part of the Remedy Publicity. It was a Remedy Test. It discovered Forced Remedies did not stop Bank Frauds and Most Victims did not make Damage Claims.
  - 2.2. In 2009 the Expense Account Scandal motivated Prime Minister Mr Brown to issue a Protection Fraud Order to the Fixated Threat Assessment Centre to get a Mental Illness Finding Fraud against Mr John Hoath. They used the GP to make a Case Reference. A Validation Demand written by the Equity Lawyer and signed by Mr Hoath got letter from the GP that admitted there was No Medical Need for the Case Reference. The Equity Lawyer prepared the Governance Fraud Judicial Review Claim CO 11860 2009 issued on 12<sup>th</sup> October 2009 of Mr Hoath v Prime Minister Mr Brown, Metropolitan Police and Ministry of Justice. It gave the Metropolitan Police the confidence to get a Sanity Finding Opinion for Mr Hoath. It enabled use of the Corruption Proof Set for Protection Fraud Investigations by Mr Hoath, the Equity Lawyer and Metropolitan Police. In 2011, one by Mr Hoath and the Equity Lawyer got Protection Fraud Conspiracy Proof against Sussex Police Chief Constable, Crown Prosecutors, Law Courts and Sir Keir Starmer when he was Director of Public Prosecutions. His fingerprints are on Original Papers in Firearms Framing Fraud Case URN 47EE15866/11 in the Brighton Magistrates Court and Trial 2012 0131 in Lewes crown Court.
