#### Brief Circumstances

The Coronation Oath Enforcement Authority has Corruption Control Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority Responsibilities of Parliament. They decide the Corruption Remedy Priorities for each Parliament Session. They use the Corruption remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officer or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for Victims. They have a Standard Remedy Process and Fast Remedy Process.

The Standard Process needs Integrity Test Authority from Citizens and Test Management by Equity Lawyers that get Corruption Remedy Standard Proof Sets. The Crown uses Corruption Proof against the State and Profession Authorities, and Remedy Denial Fraud Proof against the Law Courts for Trial Orders by the Parliament Sessions Court of Corruption Cases for the People against the State and Unfitness Cases for the People against Officers and Authorities. Corruption Proof gets a Corruption Finding, Remedy Entitlement Findings, a series of Remedy Priority Findings for investigations that discover who is responsible and then a Remedy Priority Finding for Credibility Recovery for the Authorities. It needs Dismissal Executions by a United Parliament, Victim Identification and Case Remedies. Remedy Denial Fraud Conspiracy Proof against the Cabinet and Parliament validates use of a Forced General Election got by Time Expiry or Session Refusal, with Corruption Exposure. It increases the Retirement Rate of Governing Majority MPs and gets a Power Transfer to a New Governing Majority.

The Fast Remedy Process starts the Parliament Session with Remedy Denial Fraud Conspiracy Proof got against the Cabinet Members when they were Opposition Leaders. It validates use of Production Demands for Corruption Proof against the State, Profession Authorities and Law Courts as Defence Evidence in Any Criminal Case. It forces Case References from Investigators via superiors to Cabinet Members. Remedy Denial Fraud Conspiracy Proof against Parliament in 2023 and 2024 created the need for a Fast Remedy Process in the 2024 Parliament Session. Rape Investigation 01 YE 15441 23 and Cases K8DE4Y44 + B01B0837 + 2024 000393 were fit for purpose. Hearing Dates Notices for 27<sup>th</sup> September, 4 and 8 October 2024 got Repeat Court Frauds and Joint Liability for Cabinet Members.
