All Cases Notice of Production Demands for Corruption Proof as Defence Evidence for Citizen Mr Nkrumah against the State

Sample Cases

1. Top Police, Top Customs and Top Judges had the Biggest Drug Crime Business in the UK. They were the Biggest Drug Importers. They had the Biggest Distribution Network.
2. Top Drug Sales went with Protection Frauds.
 - 2.1. The General Protection Fraud used Paedophile Entrapment and Paedophile Framing Frauds to get Blackmail Victims. They used Key Office Appointment Frauds for the Blackmail Victims to get Reliable Fraud Services at No Profit Share Cost. The Blackmail Victims needed Constant Reassurance that had Protection Frauds. The Constant Reassurance they were given was Protection Frauds for Notorious Celebrity Paedophiles.
 - 2.2. Top Drug Sales needed Chemically Traceable Drugs for Career Sabotage Frauds against Honest Officers. They needed a Good Quality Product to ensure a Reliable Supply of Buffer Stocks for use at Short Notice for the Career Sabotage Frauds. They needed Sussex Water because it was the best for Drug Production. They needed Sussex Sites to get Sussex Water. Case 1991 191 got a Bankrupt Estate that included Somersales Farm, London Road, Crowborough, East Sussex. A Corrupt Deal required Protection Fraud Proof from Top Judges to get Protection Frauds by Sussex Police for Drug Producers. Top Judges insisted they have Appointment Powers for the Drug Production Manager because they did not trust anyone else to pay them. The Protection fraud proof provided was the Bankruptcy Case 1991 191 Judgment dated 8th June 2001. It recited Fact Admissions and Intent Admissions that were Fraud Conspiracy Proof for Victim Mr John Hoath against the Law Practices known as Cripps Harries Hall and Brachers, who were respectively, the Petitioner and Trustee. The Fraud Proof and a Remedy Restraint against the Victim was the Protection Fraud Proof Top Police accepted it. Somersales Farm was the 1st Production Site. Estate Records are Drug crime Proof and Protection Fraud Proof.
 - 2.3. Top Judges appointed a Known Dangerous Criminal as Production Manager. His Convictions Record got as Statutory Prohibition against Firearms Possession. He and Guilty Officers wanted Protection Frauds that would last their lifetimes. On 25th June 2002 Firearms Theft by him did not get a Prohibition Breach 5 Years' Mandatory Imprisonment. It got a Firearms Seizure and Receipt 0223607 that listed the Stolen Firearms and identified him as the Possessor. He and Guilty Officers thought the Physical Possession of the Original Receipt was a Life Time Protection Fraud Guarantee for all of them. They it got a Cabinet Seizure and Receipt 0223608 that listed the Cabinet, commented 'locked – contents not known' and identified the Possession Agent. They went to Lewes Armoury with intent to put the Stolen Firearms and Cabinet and pretend nothing had happened. They had No Key. The Standard Unlock Procedure needed the presence of the owner to identify Missing Contents and account for Unlawful Contents if any. No one dare conduct the Standard Procedure because it defeated the purposes of the Protection Fraud. No one dare conduct a Without Owner Unlock Procedure because the Known Dangerous criminal might have put in the Cabinet evidence they could not ignore. The Convictions Record, Stolen Firearms, Receipts and Armoury Records were Protection Fraud Conspiracy Proof against the Drug Production Manager and the Event Officers and All Supervision Officers from 2002 to date. They are a Corruption Exposure Time Bomb.
 - 2.4. In 2003 an Appointment Fraud got the BBC Top Journalist Post for Sex Criminal Mr Hugh Edwards and Censorship Fraud Services for the Protection Fraud Network. It ended in late 2023 when the Corruption Remedy process managed by the Coronation Oath Enforcement Authority had made enough progress to get Target Status for him in a Sex Crime Investigation. The Protection Fraud Evidence includes a Long Absence on Full Pay and a £40,000 Salary Increase for him after discovery of Compelling Guilt Proof against him.
 - 2.5. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against the European Leaders. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds. They used Business Sabotage Fraud to prevent exposure of the Election Frauds. They used a

Drug Crime Farming Fraud by the Dutch Authorities against a UK Citizen and his Dutch Distribution Manager. Everything that could go wrong for the European Leaders did go wrong. The Drug Crime Framing Frauds needed an Extradition Fraud against the UK Citizen. The UK and Netherlands did not have an Extradition Agreement. They did not have time to make one. They used Armed Dutch Police on UK Soil to supervise UK Customs and Kent Police in a Kidnap Operation against the UK Citizen. It was the 1st EU Extradition Fraud. UK Customs knew US Extradition frauds used Kidnap + Transport Sedation + Consciousness Recovery in Guantanamo Prison and Similar Places. They knew of Top Secret Kidnap + Extradition Frauds by Sole EU States. This was the 1st Overt Extradition Fraud Operation by Two EU States. The EU Leaders and the Dutch Authorities did not know that a complex series of events got Incredible Target Status in Drug Crime Investigations for the Extradition Target. They did not know that the Top Drug Dealers used his addresses as Decoy Addresses on the Carrier Movement Records of more than 70 Drug Shipments. They did so because, if anything went wrong, the Incredible Target Status would ensure Decoy Address Enquiries would get dead End Results. They knew that a Crime Complaint by the Target started the process that got the Incredible Target Status. They thought he had discovered use of his address as a Decoy Address, made a Decoy Address Crime Complaint and was assisting with the Decoy Address Investigation. The Extradition Fraud Set Up Period coincided with the Routine Drug Trafficking Period. Top Customs got News Coverage of a Big Drugs Bust and International Co-operation and took control with intent to manage Investigation Frauds. The Extradition Target was in a UK Prison with Jury Trial Rights and an Investigation Record that was Compelling Innocence Proof for him and Compelling Guilt Proof against the Investigators. The choice was to abandon the Election frauds and recover control of the State and Law Courts from Organised Crime, or a Corrupt Trade of Drug Crime Immunity Frauds for Extradition Frauds. The European Leaders chose the Corrupt Trade. It got a Drug Crime Profit Share for Prime Minister Mr Blair. The 2nd Extradition Fraud Plan required Innocence Evidence Concealment Frauds by the UK Authorities before completion of the Prison Frauds by the Dutch Authorities. Equity Lawyer Mr Ellis and Queen Elizabeth used the 1st Extradition Fraud Proof to revive the Coronation Oath Enforcement Authority. The Equity Lawyer got Innocence Evidence Concealment Fraud Proof against UK Judges. It got Corruption Findings and a Dismissal Decision against Prime Minister Mr Blair. Continuing Protection Frauds needed Cabinet Members to have Drug Crime Profit Shares. In 2008 an Appointment fraud got the

- 2.6. In 2005 a Firearms Certificate Renewal by Mr Hoath was a Corruption Exposure Threat. It motivated a Drug Crime Framing Fraud by Corrupt Officers against him. The Convictions Record of the Drug Production Manager and Other Evidence was Compelling Guilt Proof against them.
- 2.7. In 2008 an Appointment Fraud got the Director of Public Prosecutions Post for Keir Starmer and Protection Frauds from him for the All Businesses of the Protection Fraud Network
- 2.8. In 2009 a Goods Collection Notices by the Replacement Armourer was a Firearms Theft Notice that prompted Case History Questions by Mr Hoath and got Copy Receipts from her. He had the Time Bomb Proof Set. The Equity Lawyer helped him use them for a series of Integrity Tests that got Protection Fraud Proof against Sussex Police Chief Constables, Sussex Crown Prosecutors, the Law Courts and Director of Public Prosecutions Sir Keir Starmer. The Original Case Records have Finger Print Proof that is Personal Responsibility Proof against him

3. A Corrupt Deal traded Protection Fraud for a Profit Shares from Housing Association Frauds. It used many thousand Tenancy Forgeries as Fraud Commitment Proof from Housing Association Officers. Forgery Complaints by Citizen Mr Nkrumah motivated Protection Fraud Demands by the Housing Officers that motivated Framing Frauds by Police Officers, Crown Prosecutors and the Law Courts. A Profit Share Demand got a Share Refusal by Top Judges and Framing Fraud Expert Resource Allocation Refusals by Top Police. Protection Fraud calls by the Law Courts got Incompetent Framing Frauds by Idiot Officers. It got Corruption Proof that is Defence Evidence in All cases for All Citizens. They include an Attempted Drug Crime Framing Fraud.
