Settlement Negotiation Offer + Mental Health Fraud Benefit Notice

A series of International Summits of the G7, G20 and Commonwealth Conference got Endemic Corruption Admissions and Remedy Management Agreements by Honourable World Leaders that they could not manage in their Office Terms and State Budgets could not and should not finance. They needed a Sovereign State to manage Corruption Exposure they could use to get an International Agreement for Remedy Enforcement against Fraud Profiteers. They needed Corruption Remedy Jurisdictions that the State did not control and could survive Elected Office Time Limits.

The Coronation Oath Enforcement Authority of the UK was the only one. They manage a Corruption Remedy Process. It used Repeat Series of Integrity Tests of the Authorities to force State Officers and Law Court Judges to choose between managing Just Remedies, Enforcement Refusals and Enforcement Frauds. In 2021, Dismissal Decisions against Top Judges were an Integrity Test of the Cabinet. Dismissal Failures were Protection Fraud Proof against the Cabinet. The Default Penalty was a Dismissal Decision against Prime Minister Mr Johnson. Dismissal Help Requests by Governing Majority MPs got Help Refusals by Opposition Leader Sir Keir Starmer. The Refusal Reason was that he had Corruption Joint Liability with Top Judges got when he was Director of Public Prosecutions. It created the need for Forced Remedies. It needed Imprisonment Fraud Proof against Top Judges. It needed use of it by the Parliament Sessions Court for an Imprisonment Fraud Finding, Protection Fraud Finding and Enforcement Fraud Finding, and then Exposure Blackmail to get Mass Publicity for Corruption Exposure. In December 2023 it enabled the G7 Summit to get an International Agreement for Remedy Enforcement against Fraud Profiteers. In 2024 it enabled exposure of the Post Office Scandal and Health Scandals with the Damage Payments by Fraud Profiteers. The 2024 Parliament Session was the first to start with Corruption Proof got against the Cabinet when they were Opposition Leaders. It enabled Rapid Progress of Integrity Tests that got Joint Liability Proof against Cabinet Officers for State Frauds and Court Frauds. The Cabinet needed Mental Health Frauds against Equity Lawyer Mr Edward Ellis and New Framing Frauds against Citizen Mr Nkrumah. Order Frauds by the Cabinet got Service Refusals by Commissioner Rank Police. The Complaint Settlement Negotiation Offer is an Integrity Test. It will get Just Remedy Proof for the Responsible Individuals and Medical Profession or Remedy Denial Fraud Proof against them.
