Open Invitation for anyone to support the Propaganda Fraud Complaint of Equity Lawyer Mr Ellis against Independent Television News and the British Broadcasting Corporation.

Sex Crime Investigation Denial Fraud Remedy Action Assistance Request

1. Assistance Request from Citizen Mr Antonakis Katsiaounis. He was born in 1940. He is accused of rape. In December 2023 a Rape Complaint to the Metropolitan Police got Investigation 01 YE 15441 23. In January 2024 a Written Production Demand for Corruption Proof as Defence Evidence. It got Case References by the Investigator via Commissioner Rank Police to the Home Secretary and Prime Minister. No one dare accept responsibility for creation of an Interview Audio Record of the Production Demands, or Demand Failures that was Case Sabotage Fraud Proof against the State Paid Defender. The result is Recorded Interview Refusals and Repeat Case Delays. The Corruption Proof is:
 - 1.1. A Corrupt Deal got Child Protection Fraud Co-operation for the State from the Father against his 6 children, their Mother, and their Maternal Relatives in exchange for Divorce Property Frauds by the Law Courts for him against her. Mr Katsiaounis is their Maternal Grandfather. The Child Protection Frauds got Official Records. State Records are Child Protection Fraud Conspiracy Proof against Corrupt Officers and Fraud Profiteers. Bank Records provide the Money Laundering Trail that leads to Identifiable Assets. Court Audio Records are Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds that provided Protection Frauds for the Corrupt Officers and Fraud Profiteers. The State Records includes Child Protection Investigation Frauds by the Metropolitan Police. In July 2016 the Mother discovered the Coronation Oath Enforcement Authority and the Remedy Process they manage. She gave it use of her cases.
 - 1.2. The Bail Conditions are a Family Records Access Denial Fraud
 - 1.3. Additional Evidence Notices from Corruption Victims for Live Cases gets Relevant Evidence Status for New Court Frauds.

2. Assistance Request for Citizen Mr Akwasi Nkrumah. He was born in 1983. He is the Father of 3 children. The Mother is Chronically Immature. He has provided much of the Child Care. The Root Problem is Protection Frauds for Corrupt Officers. The Protection Fraud Network made a Business Expansion Plan for Housing Association Frauds. It needed a Big Business for a Priming Case. It used Association Mergers to get a Big Business. It used Fraud Commitment Proof from Housing Officers. It was many thousand Tenancy Forgeries, and Evidence Acknowledgement Failures the Standard Practice. A Forgery Complaint by Tenant Mr Nkrumah was an Exposure Threat. Protection Demands by Housing Officers forced a Protection Fraud Call by Top Judges. It got a Framing Fraud and then a Profit Share Demand by Top Police. A Profit Share Refusal by Top Judges got a Framing Fraud Expert Allocation Refusal by Top Police. Effective Defence by Mr Nkrumah motivated Protection Fraud Calls by Court Officers that got Service Refusals by Competent Officers and Incompetent Services by Idiot Officers. In 2020 Mr Nkrumah discovered the Coronation Oath Enforcement Authority and Corruption Remedy Process. He gave it use of his cases. They got complete sets of Fraud Conspiracy Proof against the State and Law Courts. The Protection Fraud Network used a Perverted Science Teacher as a Ruin Fraud Agent against Mr Nkrumah. Rape Framing Fraud failed because the Mother needed Total Supervision. A Behaviour Change motivated Under Aged Sex Enquiries by Mr Nkrumah about the 15 year Old Daughter. It got Stress Behaviour and a Rape Complaint Fraud Blackmail by the Mother against him. All of it raised Prostitution Grooming Suspicions. A Blackmail Fraud Complaint by him got Child Protection Investigation Denial Fraud Proof against the Metropolitan Police and Barking and Dagenham Council.

Formal Request for Joint Claims by Victims and Religious Leaders for Investigation Denial Fraud Remedy Action
