Remedy Proposals

1. Housing Frauds Case Finding + Exposure Concealment Motive Suspicion Finding + Ruin Fraud Conspiracy Suspicions Finding + Criminal Complaints Findings + Pending Remedies All Case Stay Order + Contempt Investigation Order for Citizen Mr Nkrumah against the State for the REASONS that
 - 1.1. The Coronation Oath Enforcement Authority is managing a Corruption Remedy Process. It uses Known Court Frauds for Unfitness Cases against the Cabinet. All Cases that result in Court of Appeal 2024 1159 + Crown Court 2022 0043 + 2023 0058 + 1180 got Known Court Fraud Findings by the Parliament Sessions Court for Citizen Mr Nkrumah and the People. They are Relevant Evidence in Unfitness Cases against the Cabinet. It uses Known Fraud Additional Evidence Notices for Rape Investigation 01 YE 15441 23. They get Case References from the Investigator and Investigation Power Requests and Resource Requests by Commissioner Rank Police Officers to the Cabinet.
 - 1.2. The Key Test Cases are Land Frauds from for the 38 years from 1986 to date by Hackney Council against Citizen Mr Cant, the Trust Land Frauds from 2002 to date against Citizen Mr Sham Sood and the State Housing Land Frauds from 2014 that motivated a Ruin Fraud Conspiracy against Citizen Mr Nkrumah.
 - 1.3. Business Expansions Plans for Protection Frauds need Business Priming Cases to get Fraud Knowledge Admissions + Remedy Denial Fraud Commitments from Fraud Service Professionals and get Target Status for Career Sabotage Frauds against everyone who is an Exposure Risk.
 - 1.4. In 2007 a Business Expansion Plan used Land Frauds for Big Landowners against Small Businesses. The Business Priming Case Targets included Restaurateur Mr Can Say and Farmer Mr Charles Sydney Ellis. Good Case Management got Complete Sets of Fraud Conspiracy Proof for them against the Landowners, Representatives, Experts, Arbitrators, State and Law Courts.
 - 1.5. In 2014 the Remedy Process had made so much progress that the Protection Fraud Network needed a Business Explanation Plan to avoid Total Collapse. They used Family Sabotage Frauds + Child Thefts to get Big Care Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services from Sovereign States. The Business Priming Case against Mrs Theodorou and her 6 Children got a Complete Set of Fraud Conspiracy Proof in UK and Cyprus. The 2014 Expansion Plan also used Housing Association Land Frauds. It used Housing Association Mergers to get a Big Business. It needed Commitment Proof from Housing Officers to get Protection Frauds from Top Judges. The Commitment Proof was many thousand Tenancy Forgeries and a Management System that used Evidence Acknowledgment Failures to service Evidence Exclusion Frauds. Forgery Complaints by Tenant Mr Nkrumah motivated Protection Fraud Demands by Housing Officers, a Service Call by Top Judges and Framing Frauds by the Metropolitan Police. A Profit Share Demand by Top Police got a Share Refusal by Top Judges and a Framing Fraud Expert Resource Allocation Refusal by Top Police. Good Case Management by Mr Nkrumah motivated Protection fraud Calls by Court Officers. They got Service Refusals by Competent Officers and Incompetent Services by Idiot Officers. A Total Prohibition by Commissioner Rank Officers for use of Police Officers as Framing Fraud Witnesses got dependence on a Science Teacher as Influence Agent to get a Rape Complaint Fraud by the Chronically Immature Mother of his 3 Children against him. It was a Spectacular Failure. It linked Sex Investigation Denial Fraud + Family Sabotage Frauds to Land Frauds.
