Royal Commission + Family Sabotage Damage Mitigation Notice from the Equity Lawyer 13th December 2024

From: Equity Lawyer Mr Ellis

To: Metropolitan Police Commissioners + 01YE15441 23 + 01KW6359 24 Investigators

The Common Law imposes a Damage Mitigation Obligation on All Parties. Complaint Frauds got Investigations 01YE15441 23 + 01KW6359 24, did Family Sabotage Damage and got Bail Conditions that did Defence Case Management Sabotage Damage against Mr Katsiaounis and Mr Nkrumah. Damage Mitigation needs confirmation that contact between the Equity Lawyer and Family Members will not be classified as an Indirect Communication Bail Breach by Mr Nkrumah. The Contact Priority on 13th December 2024 is the letter from the Equity Lawyer to Kenina.

Ms Kenina Nkrumah,

I have met you, your brothers, your mother and some others in your family. I visited your homes on a few occasions and you have visited mine once. You presented as being a bright.

The challenge for parents is helping all children achieve Optimum Management of the Independence Journey. It has been particularly difficult in your case.

Most people notice Wrongs and reject Remedy Obligations. Natural Citizens accept Remedy Obligations. Your father is a Natural Citizen.

A Criminal Conspiracy for Land Frauds against the State used many thousand Forged Tenancies created a Remedy Obligation for everyone. It got Forgery Complaints by you father. He did not know it was a Corruption Exposure Risk for Top Criminals including some Top Judges and Top Politicians. They made a Risk Control Plan. It needed Crime Framing Frauds against you father. Good Management by him got Failure Results for them and Sabotage Damage to the family. When it started there was nothing he could do to stop it.

In 2020 your father discovered the Coronation Oath Enforcement Authority. They have Parliament Session Powers. They manage the Profession Authority Responsibilities for Parliament. They manage Corruption Investigations of the Law Court and Parliament. They provided the only chance he had of stopping the Ruin Frauds against him and the Sabotage Damage to the family. He gave them use of his cases. They used the Case Results for him and others to decide the Corruption Remedy Priorities for the Session Grants from the Crown to Parliament in 2021, 2022, 2023 and 2024. They got an International Agreement for Remedy Enforcement against Fraud Profiteers.

All of this has coincided with the time you were growing up. You sent a text to your father stating that you are not a baby any more. Everyone knows that. The issue is how much Adult Responsibility you can cope with.
