The Skeleton dated 10th January 2025 gives Brief Explanations of the Coronation Oath Enforcement Authority, Corruption Remedy Process, Co-ordinated Legal Management by UK Citizens and Co-ordinated Political by the US President Elect Team and UK Opposition Party Leaders used Child Prostitution Scandal to make Corruption Remedies the Key Issue for the 2025 General Election. The Additional Skeleton gives a Brief Update.

The Suez Scandal was a disgraceful end to the Colonial Era for the UK and France. The Scandal Response of their Governing Majorities was to create a Civil Dictatorship Plan for Western Europe. It needed Systematic Governance Frauds. They needed a Remedy Powers Monopoly in the State. They agreed the European Constitution. It vested a Remedy Powers Monopoly in the State. In every Member State of the European Union the Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and manage Co-ordinated Corruption. They sold Market Frauds to Organised Crime, provided Protection Frauds for the Corrupt Officers who managed them, and traded Glittering Career Guarantees in exchange for Fraud Services by Corrupt Parliamentarians.

The Protection Fraud Network has a Costs Control Policy. It used Paedophile Entrapment and Paedophile Framing Frauds to get Blackmail Victims. It used Appointment Frauds to Key Offices for Blackmail Victims to get Puppet Officers and a Reliable Supply of Fraud Services at No Profit Share Cost. It used Protection Frauds for Celebrity Paedophiles to provide Constant Reassurance for the Puppet Officers.

The Protection Fraud Network had a series of Business Expansion Plans. The first was Duty Free Tobacco and Illicit Drugs. Top Police, Top Customs and Top Judges are the Top Drug Dealers. Top Drug Sales go with Protection Frauds. They use Chemically Traceable Drugs for Career Sabotage Frauds against Honest Officers. They use All Authorities with Remedy Powers for Remedy Denial Frauds. Drug Distributors get Protection Frauds for All Criminal Activity including Child Prostitution. In 2002, the Production Manager of the Chemically Traceable Drugs and Guilty Police Officers used a Firearms Theft with intent to get Protection Frauds for the lifetimes. It got a Protection Fraud Proof Set that was an Exposure Time Bomb. The Business Expansion Plans for Bank Frauds, Insurance Frauds, Land Frauds and Health Frauds contaminated the Entire Business System. It created Conflicted Interests that were a Remedy Management Handicap.

In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds. The European Leaders made an Election Fraud Concealment Plan. It used Sabotage Frauds against the Lawful Business. Everything that could go wrong for the European Leaders did go wrong. The First Execution failed. It discovered the Top Police, Top Customs and Top Judges were the Top Drug Dealers. The Second Execution Deal got Immunity Frauds for Top Drug Dealers, Extradition Fraud Services for the European Leaders and a Drug Crime Profit Share for Prime Minister Mr Blair.

All of it got Fraud Proof. Equity Lawyer Mr Ellis and Queen Elizabeth used it to revive active service of the Coronation Oath Enforcement Authority and start a Corruption Remedy Process. It has continued ever since.

In 2006 the Remedy Process used Protection Fraud Proof to get a Forced 10 Months Retirement Notice from Prime Minister Mr Blair. He needed Protection Frauds that would last his lifetime. He used Profit Shares for Cabinet Officers. The Protection Frauds they managed included a Career Deal that got the office of Director of Public Prosecutions for Keir Starmer. He provided Protection Frauds for Celebrity Paedophiles. The 2010 Parliament Session Grant required a Corruption Investigation of the Law Courts managed by the Lord Chancellor for the Crown. In 2011 and Integrity Test used the Corruption Exposure Time Bomb Proof Sets. It got Protection Fraud Proof against Sussex Police Chief Constable, Sussex Crown Prosecutors, Law Court Judges and Director of Public Prosecutions. Defence Case Papers bear Fingerprint Proof against Keir Starmer. He needed to become an MP and manage Protection Frauds in Parliament.

The Trust Fraud Remedy Cases of Citizen Mr Sood got Order Breach Contempt Proof against Trustee Son Mr Sood and Contempt Immunity Fraud Proof against the Law Courts. The Ruin Fraud Conspiracy against Citizen Mr Nkrumah got linked Land Frauds + Court Frauds + Drug Dealing + Child Prostitution Protection Frauds. The Rape Investigation 01YE1544123 used it for Case References that got Child Prostitution Liability Proof against the Home Secretary and Prime Minister. Their Child Prostitution Enquiry Frauds are a Last Ditch Effort at Doomed Protection Frauds.
