

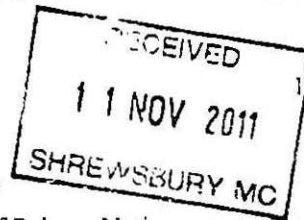

Citizen Mr Hoath in Sussex describes what could be a Court Fraud Proof Release Notice

Parliament depends on good management of Corruption Case Accountability for a reputation for integrity. Corrupt Officers use Corruption Protection Practices for Witness Intimidation + Evidence Destruction. We will discover whether Secretaries and Ministers of State recognise them for what they are and what happened to any who tried to stop them. The Trafalgar Day Citizen Restraint Reasons of Mr Justice Irwin gives you Interested Party Status in the Sussex Firearms Corruption Case - a Land Registry Fraud + a Client Money Theft Fraud. You can use Interested Party Status to investigate how Corruption Protection Practices work.

#### Investigation of Corruption Protection Practices: Sussex Firearms Corruption Case

Wealden MP Mr Hendry referred the Firearms Crimes Corruption Case to the Home Secretary. A competent investigation needed Evidence Protection + Witness Protection. Please find enclosed a photograph which includes part of the front page of the Sunday Telegraph on 6<sup>th</sup> November, a criminal witness statement dated 7<sup>th</sup> November and Case Management Proposals dated 8<sup>th</sup> November 2011.

1. Whether the Reception Tape and Receptionist Testimony prove the refusal to receive Corruption Proof in the Sussex Firearms Case from Equity Lawyer Mr Ellis at about 15:20 on 8<sup>th</sup> November 2011?
2. What are the arrangements for Evidence Protection and Witness Protection in Corruption Cases?

1. Whether he wrote a letter to MP Mr Hendry?
2. Whether the intent was to get Evidence Destruction by Corrupt Officers who should be investigated?

Please ask Wealden MP Mr Hendry

1. Whether the purpose of MP References of Corruption Cases is to discover whether State Secretaries investigate corruption or prove they are managing it by refusal to do so?
2. What are the defences to Justice Perversion Charges that are proved by procuring Evidence Destruction?

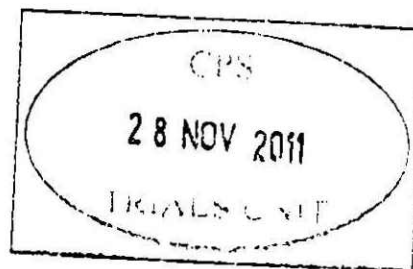
1. Whether Shropshire Council waited for the Trafalgar Day Citizen Restraint Order Fraud before issuing the Council Tax Summons?
