Corruption Proof is Justice Office Conflict Disqualification Proof against the Police and Law Courts

1. The Firearms Crimes Protection Fraud Proof Set against Mr Leachman and Sussex Police
 - 1.1. The Police National Computer Criminal Convictions Record of Mr Winston Elijah Leachman for the Validity Investigation Reason that it evidences a Statutory Prohibition against Firearms Possession and 5 Years Imprisonment Breach Penalty

Sussex Police Firearms Receipt 09223608 that lists a Firearms Cabinet and the comment 'locked – not known contents' and identifies the Possessor as Mr Ian Wise, who was the Lawful Agent of the Owner, for the Reason it is Detailed Knowledge Proof of the Firearms Licence Breach or Firearms Theft from the Firearms Cabinet
 - 1.4. Full Disclosure of All Records of the Firearms Licence Breach Investigation or Firearms Theft Investigation, Other Lawful Process or Unlawful Process that used the Firearms Seizure and Cabinet Seizure for the Validity Investigation Reason
 - 1.5. Full Disclosure of the Lewes Armoury Records of Sussex Police for the Reason they are needed to discover who knew, and when they knew about the Firearms Licence Breach or Firearms Theft + Firearms Seizure + Cabinet Seizure and the results for the Validity Investigation Reason.
 - 1.6. Full Disclosure of All Records of Sussex Police of the Firearms Theft Complaints of Owner Mr Hoath for the Validity Investigation Reason they are needed to discover whether they are Just Remedy Proof for Sussex Police or Protection Fraud Injustice Proof against Sussex Police.
 - 1.7. Full Disclosure of the Mental Health Fraud Order issued on or about 14th May 2009 from Prime Minister Mr Brown to the Metropolitan Police against Owner Mr Hoath for the Validity Investigation Reason that in 2008 Protection Fraud Proof validated Dismissal Decisions against Prime Minister Mr Brown and the Governing Majority, and a Remedy Co-operation Commitment from the Opposition Minority validated Dismissal Enforcement by use of the Expense Accounts Scandal timed to coincide with the Election Campaign Period. It forced Corruption Remedy Commitments and Remedy Support Vote Requests by the Party Leaders that got Mass Publicity, and the Secret Mental Health Fraud Order by Prime Minister Mr Brown against Owner Mr Hoath with intent to depriving him of the Legal Capacity for Remedy Action in the Law Courts.
 - 1.8. Full Disclosure of the Mental Health Fraud Case Allocation to the Fixated Threat Assessment Centre at 5 Buckingham Palace Gate, London and the Enforcement Efforts for the Validation Investigation Reason
 - 1.9. Full Disclosure of the Firearms Corruption Remedy 2009 Case 5215 of Owner Mr Hoath against Sussex Police and the Independent Police Complaint Commission [IPCC] and 2029 Case 5236 of Owner Mr Hoath against Prime Minister Mr Brown, the Business Secretary, Sussex Police and the IPCC and Fraud Appeals of the Owner to the Court of Appeal for the Validity Investigation Reason.
 - 1.10. Full Disclosure of the Mental Health Case Reference dated 2nd September 2029 by the Lews GP Dr Ross and the Validation Demand dated that day by Owner Mr Hoath that got the No Medical Beed Admission dated 3rd September 2009 from Dr Ross and use of it for Corruption Remedy Claim CO 2009 11860 of Owner Mr Hoath against Prime Minister Mr Brown, Justice Secretary Mr Straw, Metropolitan Police Fixated Threat Assessment Centre, GP Dr Ross an Sussex Chief Psychiatrist Dr Orekan for the Validation Investigation Reason that Personal Service of it on 12th October 2009 at 5 Buckingham Palace Gate it got a Loyalty Transfer by Top Police from the Prime Minister to the Crown. The Mental Health Fraud got a Sanity Finding Opinion for Owner Mr Hoath, use of it and the Firearms Corruption Proof Set for Criminal Investigations that got Protection Fraud Proof against All Authorities with Relevant Remedy Powers.
