8. The Firearms Integrity Tests of the Authorities managed by Equity Lawyer Mr Ellis
 - 8.1. Used the Witness Protection Applications by Citizen Mr Hoath that got Protection Denial Fraud Proof against the State, Law Courts and Parliament

Used the Protection Denial Fraud Proof Set and a Case Reference by Queen Elizabeth via the Metropolitan Police Special Operations Protection Command that forced the choice between a Corruption Investigation that needed Witness Protection for Citizen Mr Hoath or Protection Frauds that needed a Framing Fraud against him

 - 8.6. Used the Firearms Prohibited Possession + Unlicensed Possession Framing Trial Frauds 47 EE 5866 11 + 2012 0131 + Appeal 2012 05196 C5 RD to get Fingerprint Case Knowledge Proof against Director of Public Prosecutions Sir Keir Starmer.
