It seems sensible to include all of you in the reply.

The Who Question.

I am Equity Lawyer Mr Edward Ellis. Since 2004 I have specialised in servicing Corruption Investigations for the Coronation Oath Enforcement Authority. They have Corruption Remedy Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority responsibilities of Parliament. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Coronation Oath Enforcement Authority have Corruption Remedy Jurisdictions that govern Parliament Session Powers. They used the Election Fraud Proof to start a Corruption Remedy Process that has continued ever since.

The Want Question.

In brief the want is Full Co-operation with a Corruption Investigation that links Land Frauds by Housing Association Officers with Crime Framing Frauds by Police Officers and Law Court Judges and with Child Prostitution. It needs Witness Protection for Mr Katsiaounis, Mr Nkrumah and their families. It needs Rapid Intervention to stop the Child Prostitution of his 15 Year Old Daughter.

The Remedy Process discovered that Top Police, Top Customs and Top Judges are the Top Drug Dealers. It discovered that Top Drug Sales go with Protection Frauds that include Child Prostitution. The Rotherham Child Prostitution Scandal got a Judicial Enquiry that cost £6,000,000 and proved the Protection Frauds came from Prime Minister Mrs May and Mr Johnson and Opposition Leaders Mr Corbyn and Sir Keir Starmer. In December 2024, Forced Remedies included Mass Publicity for the Cumbria Child Prostitution Case in December 2024.

The Protection fraud Protocol requires Commitment Proof from the Receiver. Many thousand Forged Tenancies and a Management System that serviced Evidence Exclusion Frauds by making Acknowledgment Failures the Standard Practice were Commitment Proof from Housing Association Officers to get Protection Frauds from Top Judges. Forgery Complaints by Tenant Mr Nkrumah motivated Protection Fraud Demands that got Framing Frauds by the Metropolitan Police. A Profit Share Demand by Top Police got a Share Refusal by Top Judges and a Framing Fraud Expert Resource Allocation Refusal by Top Police. Competent Management by Mr Nkrumah motivated Service Calls by Court Officers that got Service Refusals by Competent Officers and Incompetent Efforts by Idiot Officers. In 2020 Mr Nkrumah discovered the Coronation Oath Enforcement Authority and Corruption Remedy Process. He has given use of his cases ever since. The Seal Ink on Original Documents and Electronic Record Inconsistencies were Record Fraud Proof against the Law Courts. Top Judges made a Original Document Theft Plan, that used a Bag Snatch Theft outside Seven Sisters Station in September 2020, and an Electronic Records Theft Plan that used a Criminal Agent to penetrate the Nkrumah Family Circle and get Theft Set Up Conditions. They were Tenancy Pretence Frauds that enabled a Private Landlord to get Physical Possession of the Electronic Devices and then commit the Electronic Device Thefts. The Set Up Agent gets Protection Frauds from the Police. He could not resist Influence Frauds over the Mother and Prostitution Grooming of the 15 Year Old Girl.

Family Sabotage Frauds have done Enormous Damage to Mr Nkrumah. The choice is Corruption Remedies for Mr Nkrumah or Life Ruin for Guilty Individuals
