

All Cases Evidence Offer + Data Protection Waiver of Witness for Citizens v State

Witness:

The Witness gives an Evidence Offer + Data Protection Waiver to service Metropolitan Police Investigations 01YE15441233 + 01KW635924 + All Other Cases in which there are Corruption Counter Charges against the State, Profession Authorities, Law Courts, Cabinets and Parliaments for the Reason that:

1. The Coronation Oath Enforcement Authority has Corruption Remedy Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority Responsibilities of Parliament. They rely on the Individual for two things and gives Citizen Status to whoever provides them. They are:
 - 1.1. Management Authority for the use of the truth, whole truth and nothing but the truth, any of their case or all of their cases for Integrity Tests of the Authorities to service the Justice Priority of the People and then the Remedy Priorities of the Individual. Integrity Tests forces the Remedy Power Possessor to choose to use them for Just Remedies or Fraud Enforcement.
 - 1.2. Evidence Offers + Data Protection Waivers to service Integrity Tests using cases of others.
2. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders. The UK Coronation Oath Enforcement Authority used it to start a Corruption Remedy Process that has continued ever since. It discovered that the Authorities had made Justice Perversions the Standard Practice. They use Inequality Frauds and Evidence Frauds for the State against the Citizen. The Remedy Process needs Test Cases to service Remedy Management.
3. Evidence Frauds achieve Truth Concealment or Falsehood Promotion or a mixture of both. Data Protection Law was designed to service both.
4. Corruption Remedies needs Test Cases to discover the most efficient way to use Standard Procedure to convert from Justice Perversion to Justice Management. UK Criminal Standard Procedure uses the Formal Caution: 'You do not have to say anything. What you do say will be recorded in writing and may be used in evidence. It may harm your case if you fail to mention anything that you wish to use in court.' Standard Procedures uses it for the Counter Charge but not the Counter Charge Caution.
5. Corruption Remedies needed Two Stage Test Cases
 - 5.1. Use of the Formal Caution for Production Demands of Corruption Proof as Defence Evidence
 - 5.2. Use of the Counter Charge for a Formal Caution of the Case Investigators
6. The Test Cases needed Evidence Offers and then Evidence Offers + Data Protection Waivers for a Risk Control.
7. The Production Demand Test used a Rape Complaint Fraud by a Damaged Young Woman. She is a Childhood Prostitution Victim. Family Sabotage Frauds + Children Thefts got Big Budgets + Budget Fraud Profits and Expatriation Frauds got Money Laundering Services from Sovereign States for Corrupt Officers. It did Self Confidence Damage + Identity Damage to some Child Victims. Employer Friends helped Lucky Ones to recover. Unlucky Ones suffer True Identity Rejection + False Identity Adoption and made mistakes. Some use Guilt Transfers to cope with Mistake Stress. The Rape Complaint Fraud got Investigation 01YE1544123 + Arrest + Bail Condition Frauds that achieved Defence Evidence Access Denial Frauds + Defence Case Management Sabotage Frauds for the for the State against the Citizen. The Production Demand Response was a Second Recorded Interview Failure and Case References from the Investigator via superiors to Commissioner Rank Police. No one dare accept responsibility for creation of Interview Audio Records of Corruption Proof Production Demands or Demand Failures that were Fraud Conspiracy Proof against the Defender and Investigator. No one dare accept responsibility for a Case Closure Decision. It got Bail Return Appearances by Accused and Appearance Failures by the Defender and Investigator. It got Bail Appeal Process Denial Fraud Proof against the Police and Magistrates Court. It got Remedy Process Denial Fraud Proof against the Administration Court and High Court. Meanwhile, it got Case References by the Commissioner Rank Police to the Home Secretary and Prime Minister. The Bail Conditions expired. No one dare accepts responsibility for a Case Closure Notice + Seized Good Return. The Test Case continues with a Remedy Denial Fraud Appeal to the Court of Appeal.
8. The Production Demand Test + Counter Charge Caution Test uses Harassment Complaint Fraud + Investigation 01KW635924 + Seizure Frauds that are Electronic Device Thefts for Evidence Concealment Frauds. Reasonable Suspicions of Prostitution Grooming of a 15 Year Old Girl by a Science Teacher, Sex Activity Questions by the Father, Rape Complaint Blackmail by the Mother and a Blackmail Fraud Complaint by the Father got Child Prostitution Protection Fraud Proof against the Police and Local Authority. Evidence Concealment Frauds used Investigation 01KW635924 for Evidence Thefts. 2025 started with a Bail Conditions Appeal Adjourned Hearing.
