Upon reading the Bail Appeal Case Papers and hearing the Citizen Father Mr Akwasi Nkrumah and Metropolitan Police Officers

1. Case Priority Dilemma Finding for the Citizen Father, Mr Nkrumah, and Metropolitan Police for the Reasons that:
 - 1.1. The Citizen Father makes a Child Prostitution Complaint
 - 1.2. The Child's Mother makes a Harassment Complaint against the Citizen Father,
 - 1.3. The Common Law requires Welfare Priority for the Vulnerable against Others and Vulnerable Children against Vulnerable Others
 - 1.4. State Practice ignores Relative Vulnerability and Common Law Priorities imposes Case Priority for Women against Men
2. Case Management Priority Finding for the Common Law against State Practice for Justice Management Reasons
3. Welfare Priority Finding for the 3 Children against Children's Mother, Ms Laetticia Musaka and the State for Justice Management Reasons
4. Contempt Investigation Order + All Cases Pending Remedies Enforcement Stay Witness Protection Order for the Citizen Father and his 3 Children for Justice Management Reasons
5. Contempt Investigation Resource Reference for the Citizen against the Cabinet
6. Negotiation Authority for the Citizen Father and the State to trade Criminal Immunity for the Children's Mother in exchange for Full Disclosure about everything concerning the Parents' Relationship, Child Welfare, the Drug Crime Framing Fraud in January 2021 for the Reason that:
 - 6.1. The Coronation Oath Enforcement Authority has Corruption Remedy Jurisdiction that govern Parliament Session Powers. They manage the Profession Authority responsibilities of Parliament. In 2004 they got Corruption Proof against Top Officers. They used it to start a Corruption Remedy Process. It has continued ever since. It discovered Top State Officers and Top Judges are the Top Drug Dealers and Top Drug Sales go with Protection Frauds that includes Child Prostitution.
 - 6.2. A Child Prostitution Enquiry focussed on Rotherham because there were Willing Witnesses, cost £6000,000 and provided the Protection Frauds came from Prime Ministers Mrs May and Mr Johnson, and Opposition Leaders Mr Corbyn and Sair Keir Starmer. The progress since then includes Child Prostitution Criminal Convictions in Cumbria with Mass Publicity in December 2024. The Citizen Father had Reasonable Suspicions of Prostitution Grooming of his 15-Year-Old Daughter. Sex Activity Questions by him got the Rapid Response of Blackmail by the Children's Mother using a Rape Complaint Threat to deter the Sex Activity Questions. A Blackmail Fraud Complaint by the Citizen Father got Child Protection Failure Proof against the Metropolitan Police and Barking and Dagenham Council. Electronic Records were on Electronic Devices. A Harassment Complaint by the Children's Mother got an Arrest + Electronic Device Seizure + Bail Conditions that prevent Child Protection by the Citizen Father. The Bail Conditions Appeal forced the choice that got the Child Welfare Priority Decision.
7. Witness Protection Details Filing Time Limit of 4 p.m. on Tuesday 7th December 2025 + Protection Breach Contempt Penalty Warning for the Citizen Father against All State Officers
8. Appeal Leave subject to a 7 Day Time Limit for the Cabinet
9. Appeal Leave subject to an Immediate Case Reference to the Commissioner Rank for the State
