

Remedy Process + Remedy Proposals

The Remedy Process Risk Assessment Event on 10th January 2025 and the Event Report dated 13th January 2025 will get either will get Justice Proof for Authority Officers or Remedy Denial Fraud Proof against them.

The Norman Invasion got Rapid Change from Equity Governance to Dictator Governance. The Doomsday Survey discovered the Extortion Limits. The Dictator Governance Plan for Western European got Gradual Imposition of Dictator Governance. The Wind of Change Speech by Prime Minister Mr Harold MacMillan was a Change Notice from Equity Governance to Dictator Governance. The People knew it was wrong. They made the Equity Governance Recovery Plan. It used the Remedy Process Test Notices that identified Remedy Co-operators and Remedy Resisters. Many knew something is happening. Many know now there is a Remedy Process. Others need a Clear Explanation. There is a Good Will Wave. It needs converting from a Temporary Phenomenon into a Permanent Structure.

The Best Advice is a Recognition Network by the People for the People. In 1998 the UK Citizen got the World Lead for Advanced Electronic Signature Technology. It enabled Behaviour Identification by Computer Users and an Identity Proof Powers Transfer from the State to the Citizen. The Business Plan was On Line Services. The Defence Plan was Source Code Secrecy. Market Access needed either the High Internet Usage of the USA or the Universal Deliveries of Royal mail and the Post Office in the UK. Equity Lawyer Mr Ellis had 50% Copyright + 100% Marketing Rights + Creditor Control. He wanted Hub Business Profits for the UK. The Business Plan included use of the Post Office for Trust Management Services. He expected Business Profits to need UK National Debt Reduction as an Inflation Control. He intended Business Profits to finance Foreign Investment that provide Migration Disincentives, and Palestinian Enrichment that forced Policy Changes by Israel. The European Leaders made a Personal Profit Plan. It needed Source Code Theft, Sabotage Frauds against the Post Office, Forced Usage in the European Union and Usage Licence Fees for the Theft Conspirators. It failed. They used EU Market Exclusion Frauds against him. The Proof Positive includes the Advanced Electronic Signature Statutory Instrument 2002 that was copied throughout the EU. It vested Licence Powers in the State. Licence Enquires discovered No Licence Forms + No Licence Process. He used Fraud Proof to manage USA Market Exclusion Justice for him against Executable Code Use Frauds by them. In 2004 he used Fraud Proof against them to revive Active Service of the Coronation Oath Enforcement Authority. They started the Corruption Remedy Process. It has continued ever since. It has enabled a Viable Minority in the UK to achieve Remedy Belief. It needs convert the Viable Minority in the UK into a Massive Majority. It needs to provide Support Services for Corruption Remedy Processes in all Sovereign States that want it.

Corruption Remedies needs Remedy Discipline. It needs Wrong Recognition and the Valid Remedy Options. A Valid Remedy needs a Risk Control against Further Damage. It needs Self Help Support Services that enable Victims to get Valid Remedy Qualifications. All of it needs an Efficient System that can cope with Remedy Complexities that includes Trust Management.

A Sample Bad Case is Corruption Victims who suffered Identity Damage. They have Zero Confidence in Consensual Relating. They use Relationship Sabotage against others to get Perverse Satisfaction. Financial Damages carry a Massive Risk of Perversity Empowerment. Financial Remedies for them need Consensual Relating Successes as the Validity Qualification. A Less Bad Case is Superiority Fantasies and Real Life Fantasy Busting Experiences that cause Failure Stress and Repeat Drug Abuse. Financial Damages carry a Recovery Delay Risk and Death Risk. Financial Remedies for them need Normal Life Successes as the Validity Qualification. A Good Case is a Corruption Victim who had Less Damage with Good Luck that got Self Help Support from a Good Employer. A Valid Remedy is Small Scale Business Finance Test that enables the Victim to develop Management Skills. Financial Remedy needs either High Skill Proof or Personal Discipline that acknowledges the Skill Limit. Many Miserable Cases revealed that a Building Successes with Repair Work and Single Houses got Estate Development Finance that did Life Ruin Damage.

The UK Post Office survived Sabotage Frauds by Top Manager well enough for Office Masters to provide Identity Management Services. It will enable an Identity Proof Power Transfer from State to Citizen. The Test Services can start with Remedy Enforcement for Scandal Victims against the Post Office + Top Managers + Case Management Lawyers. They can proceed with Remedy Management Services that match Service Providers with Test Case Victims. Develop it in UK. Let the world benefit from the Remedy Process Experience and the Common Law.
