1. The 01KW635924 Electronic Records Access Request Email at 12.09 on 20th January 2025 from Investigator Megan Lelliot using <megan.lelliot@met.police.uk> gets an Access Refusal for the Reasons that
 - 1.1. A Child Prostitution Concealment 1st Plan used Blackmail Influence Frauds by Science Teacher Mr Benjamin Koomson got Rape Complaint Fraud Threats by Mother Ms Laetticia Mukasa against Father Mr Akwasi Nkrumah to deter Sexual Activity Questions by him. The Blackmail Complaint dated 14th October 2024 by the Citizen Father supported An Additional Evidence Notice for Investigation 01YE1544123 got Case References from the Investigators and Commissioner Rank Police that got Protection Fraud Proof against Cabinet Officers.
 - 1.2. The 1st Plan Failure motivated the 2nd Plan. Influence Frauds by Science Teacher Mr Benjamin Koomson got the Harassment Complaint Fraud by Mother Ms Laetticia Mukasa and the Arrest Fraud + Electronic Device Seizure Frauds against the Citizen Father. Corruption Proof Production Demands by the Citizen Father got Total Trap Conditions against the Plan Conspirators. Additional Evidence Notices got Case References that Plan Conspiracy Proof against Cabinet Officers.
 - 1.3. UK Opposition Leaders made Corruption Remedy Commitments. They need Outside Help to counter Remedy Sabotage by Opposition Grandees. The US President Elect Team provided the Outside Help. They used the Child Prostitution Scandal to enable the Opposition Leaders to make Remedy Demands that included a National Enquiry. It motivated the Ludicrous Pretence on 6th January 2025 by Prime Minister Sir Keir Starmer that Child Prostitution Remedy Demands were Extremism Band Wagon Politics. The Ludicrous Pretence and Enquiry Limit Frauds added to the Protection Fraud Proof against the Cabinet. All of it made Corruption Remedies the Key Issue for the 2025 General Election.
 - 1.4. A Risk Investigation by Vulnerable Officers used an Introduction Request by an Investigation Agent to the Citizen Father that on Friday 10th January 2025 got an Introduction + Risk Briefing from Equity Lawyer Mr Ellis. He produced the Firearms Corruption Proof Set, Firearms Crime Framing Fraud Trial 2012 0131 Case Papers and Fraud Appeal 2012 05196 C5 RD Case Papers that are Drug Crime Protection Fraud Proof against Sir Keir Starmer when he was Director of Public Prosecutions. He explained that Total Trap Conditions against the All Plan Conspirators including Cabinet Officers. He explained the Drug Dealing Proof against the Science Teacher was Car provision for Errand Journeys by Uninsured Drivers and use of the Errand Period Absence for Drug Collection from the Car Boot by Receivers. Driving Crime Arrests got No Car Seizures and exclusion of the Car Provider Details from Prosecution Records. Mercy Expectation Questions by the Equity Lawyer got No Mercy Expectation Findings by the Investigation Agent against everyone in the Concealment Plan Hierarchy. The Best Advice via the Investigation Agent to Vulnerable Officers was to create Remedy Co-operation Proof. It needed Immediate Action that got Practical Parental Control for the Citizen Father.
 - 1.5. Remedy Co-operation Advice from the Investigation Agent got Case Management Activity that adds to the Guilt Proof against Vulnerable Officers.
 - 1.6. Child Prostitution Public Enquiries have Jurisdiction Superiority over Metropolitan Police Investigation 01KW635924. It got Child Prostitution Protection Fraud Proof that is Conflict Disqualification against the Investigation Officers and Barking and Dagenham Council Officers.
 - 1.7. The 2025 01 20 Justice Process Contempt Fraud Evidence Offer + Complaint Statement of the Citizen Father makes Disclosure Commitments that include the Electronic Device Passwords.
