

2025 Election Integrity Test Notice PRECEDENT for All Citizens

Formal Demand for Election Campaign Commitments for:

1. Enforcement of the Coronation Oath for Equity Governance using the Common Law
2. Use of the Common Law Corruption Controls:
  - 2.1. The Integrity Controls of separation of the jurisdictions of legislation, investigation, prosecution, agency defence, trial adjudication and appeal adjudication
  - 2.2. A Neutrality Qualification for the Justice Offices of investigator, prosecutor, defender, trial adjudicator and appeal adjudicator
  - 2.3. Anything that is or might appear to be a Conflicted Interest and Neutrality Disqualification Breach for a Remedy Only Jurisdiction Limit
  - 2.4. Any Justice Office Tenure earlier in a Case Process is a Conflict Disqualification from Justice Offices later in the Case Process
  - 2.5. Anything that is or might appear to be Conflicted Interest and Neutrality Obligation Breach that creates a Remedy Only Jurisdiction Limit.
  - 2.6. A Voluntary Disclosure Obligation by all Justice Officers of anything that is or might appear to be Conflicted Interest and Neutrality Obligation Breach that creates a Remedy Only Jurisdiction Limit.
  - 2.7. A Voluntary Disclosure Obligation Failure gets Invalid Status for the Case Process and Inadmissible Status for the Process Evidence.
  - 2.8. A Case Management Capacity Equality Investigation and Inequality Remedies
  - 2.9. A Start Position for the Evidence Balance of a Validity Presumption for the Citizen and Credibility Presumption for the State both of which are subject to Rebuttal Proof Positive
  - 2.10. Fraud Proof of anything gets a Proof Burden Reversal and Fraud Presumption of everything else for the Victim and Citizen against the Fraud Manager and Fraud Beneficiary subject to A Treason Liability Protection Forfeit Penalty for the Victim and Citizen against Corrupt Officers
  - 2.11. Priority in all cases for a Validity Investigation to discover whether a Corruption Controls Breach invalidates any earlier stage of the Case Process, and if so, the Invalidity Remedies
3. Use of the European Constitution and Many Cases for Common Law Corruption Control Breach Findings
4. Use of Common Law Justice Process Contempt Powers for Remedy Management
5. Use of Common Contempt Remedy Management:
  - 5.1. A Passive Enforcement Stay Protection Presumption for the Victim subject to Rebuttal Proof Positive
  - 5.2. Investigation whether Active Remedies for the Victim is a Predictable Consequential Damage Risk for Others or a Predictable Personal Recovery Delay Risk for the Victim.  
*REASONS: Corruption caused or contributed to Personality Damage in some Victims. The Worst Cases cannot get Personal Satisfaction from Relationship Successes. They get it from managing Relationship Failures by others. Unconditional Financial Remedies will be Perversity Empowerment that is a Consequential Damage Risk for others. The Financial Remedy Conditions must be Behaviour Changes. Lesser Cases are the Personality Damage of Natural Identity Confidence Deficits and False Identity Fantasies with real life providing Fantasy Busting Experiences that cause the Failure Stress Response of Drug Use. Unconditional Financial Remedies will be False Identity Finance with an Increased Drug Use Risks. The Financial Remedy Conditions must be Behaviour Changes. Many cases evidence Sex Rape Child Victims become Adult Abusers. Remedy Process Cases raise Reasonable Suspicions the Court Fraud Rape Legacy includes Child Victims who want to become Adult Abusers. Corruption Remedies needs the ability to service the Coronation Oath Enforcement Authority to be the Key Qualification for All Qualifications with Breach Prosecution Powers and Jury Trial Rights for the Victim and Citizen. The Court Fraud Rape Legacy increases the urgency for the Profession Controls.*
6. Further Commitment Rights Reserved for the Citizen
