

Election Integrity Test Case Notice + Representation Accountability Request

To: Constituency MP

REASONS:

1. The Child Prostitution Scandal, Remedy Proposals of the Opposition Leaders and Remedy Rejection of the Cabinet made Corruption Remedies the Key Issue for the General Election. It added to the Remedy Denial Fraud Proof Set against the Cabinet. All of it validates a Parliament Session Refusal and Forced General Election.
2. It is Good Practice for Citizens to manage Election Integrity Tests.
3. This Election Integrity Tests uses
 - 3.1. the Royal Commission + Metropolitan Police East Area Command Child Prostitution Enquiry + Witness Protection Motion dated 29th January 2025 of MPs for the People v Cabinet
 - 3.2. The Representation Accountability Request of the Constituent to the MP

REASONS:

1. The Integrity Test will get Just Remedy Proof + Election Credibility Proof for Motion Proposers and Remedy Denial Fraud Proof + Election Incredibility Proof against Motion Resisters.
2. The Integrity Test will get Just Publicity from Honest Media Managers and Unjust Publicity or Unjust Publicity Failures that are Propaganda Proof against Corrupt Media Manager
3. The Integrity Tests will get Election Campaign Questions that are Election Fairness Proof for Honest Election Managers or Election Campaign Question Denials that that are Election Unfairness Proof against Corrupt Election Managers
4. The Election Integrity Tests will get Remedy Co-operation Proof for the MP or Remedy Denial Fraud Proof against the MP. A Key Test is whether Motion Support Evidence Offers by Citizens get Evidence Acceptance by MPs or Evidence Exclusion Frauds by the MPs with use of No Constituency Resident Status for the Evidence Exclusion Fraud Reason.
5. The Integrity Test will discover whether MPs use provide Support Services for Witness Protection Claims by Citizens to Parliament.
6. The Nkrumah Family have the Key Witness Protection Test. On the evidence available, Corruption Exposure by Citizen Mr Nkrumah has motivated Isolation Frauds, Discredit Frauds and Intimidation Frauds against him and Intimidation Frauds against his young sons. Corruption Stress makes it very hard for Citizen Mr Nkrumah to convert what is happening into a Clear Explanation for use by the MP when making a Witness Protection Case. There will be mistakes. It is in the best interests of everyone if the Witness Protection Process identifies whoever made the mistake, and that it is not the MP. Corruption Remedies need a Witness Protection Application Case Costs paid by the MP and claimed as a Valid Expense. The Test Proposal is a £5,000 Budget with Citizen Mr Nkrumah choosing the Service Provider. It will Mistakes Joint Responsibility for Citizen Mr Nkrumah and the Support Provider. It will enable get a Witness Protection Comparison Case for the Service Quality and Service Cost got from Regulated Lawyers.
7. The Best Advice is that Citizen Mr Nkrumah nominate Mr Neil Lowden the Service Provider. The Advice Reason is that Mr Neil Lowden has Top Computer Skills. Citizen Mr Nkrumah has Good Computer Skills. The challenge for them is to provide an Impressive Service in a Rapid Time. It needs an Events Log to record what is happening now, work backwards and collate as much as possible of the Child Prostitution Grooming Proof Set. All of it will be Relevant Evidence for the Child Prostitution Enquiry.
