

Metropolitan Police East Area Command Child Prostitution Enquiry + Witness Protection Motion of MPs

REASONS:

1. The Child Prostitution Scandal created the need for Credibility Recovery by the Authorities. It needed many things including a National Enquiry. The National Enquiry Refusal by the Cabinet was Protection Fraud Proof against the Cabinet. It enabled the Opposition Leaders to make Corruption Remedies the Key Issue for General Election.
2. Honourable MPs have a choice. It is to get Just Remedy Proof for them or accept the failure to do so will get Remedy Denial Fraud Proof against them.
3. Honourable MPs need a Credibility Recovery Plan. It needs Good Management. Citizens knew Honourable MPs would need it. They had Corruption Cases. They used Co-ordinated Case Management to get Proof Sets that Honourable MPs would need. The Proof Sets link a set of Land Frauds + Court Frauds + Crime Framing Frauds + Evidence Theft + Drug Crimes + Child Prostitution all of which got Protection Fraud Conspiracy Proof against the Cabinet. All of it got Live Case Proof.
4. The Enquiry Choices is
 - 4.1. A Live Case Enquiry with Records Control + Responsible Individual Identification
 - 4.2. A Historic Case with Records Uncertainty + Responsible Individual Uncertainty
5. The Credibility Recovery Plan needs to start with a One Local Area, identify Linked Local Area, get the English National Areas, and then the UK Sovereignty Area. It will force a Rear-guard Action that identifies Protection Fraud Network Agents in the Cabinet and Parliament. It will get Credibility Proof for Honourable MPs who manage the process.

The Live Case

6. The Nkrumah Family have the Live Case. It is very simple. The Protection Fraud Market Protocol Market Protocol requires Commitment Proof from the Receiver before the Supply. Business Expansion Plans use Priming Cases to identify and reward Corrupt Professionals and identify and penalise Honourable Professionals. A Business Expansion Plan for Housing Association Frauds needed Commitment Proof from Housing Officers. It was many thousand Forged Tenancies and a Management System that enabled Exclusion Frauds by making Acknowledgment Failures the Practice Standard. Forgery Complaints by Tenant Mr Akwasi Nkrumah motivated Protection Demands by Guilty Officers everywhere including the Cabinet. A Service Call by Top Judges got a Framing Fraud by the Metropolitan Police. A Profit Share Demand by Top Police got a Share Refusal by Top Judges and a Framing Fraud Expert Resource Allocation Refusal by Top Police. Mr Nkrumah was born in 1983. He has a High Intellect and Technology Skills. He has never taken drugs. He gets Personal Satisfaction from Athletic Exercise and Moral Control. He has 3 children by a Chronically Immature Woman. She coped with his Moral Control and Self - Discipline long enough to get the first child, and then had Child Care Dependency on him. He was homeless. His Defence Response was to make applications, claims and complaints. The Seal Ink on Original Documents and Record Inconsistencies were Forensic Test Material for Record Fraud Investigations. Top Judges made an Investigation Sabotage Fraud Plan. It needed Original Records Theft and Electronic Device Thefts. In 2020 a hearing Event got original Documents Production from a Big Blue Bag, an Original Documents Location Report from Court Officers, a Theft Order from Top Judges and use of the Return Journey for a Big Bag Snatch Theft outside Seven Sisters Railway Station. The Electronic Device Theft Plan needed a Reliable Criminal to penetrate the Family Circle and manage a process that got All Electronic Devices in One Location for the Theft Event.
7. The Reliable Criminal needed Professional Credibility to be accepted by Mr Nkrumah. The Network chose Science Teacher Mr Benjamin Koomson as the Reliable Criminal. He is a Wholesale Distributor of Criminal Drugs. He

provides cars for errand journeys by uninsured drivers. Some of them result in Uninsured Driving Arrests with No Car Seizure + Car Provider Identity Concealment. The Most Credible Explanation is that Errand Absences enable Drug Collection from the Car Boot by Receivers.

8. Theft Agent Mr Koomson opened a Retail Shop and provided Private Tuition. He befriended the Mother's Family. They are Chronically Immature. They are Vulnerable Adults. They introduced him to Mr Nkrumah. There was what appeared to be a Befriending Process that with hindsight was Entrapment Research that failed to get Entrapment Conditions. Then Shop Minding Requests by the Theft Agent got Shop Minding Services by Mr Nkrumah that got an Influence Fraud Time for the Theft Agent with the Children's Mother. The Influence Frauds got Set - Up Conditions for the Electronic Device Theft. They were a House Move by the Children's Mother and House Tenancy Misrepresentation Frauds by the Private Landlord got Electronic Devices + Cash + All Other Goods Placement in the house by Mr Nkrumah, and then a House Exclusion Fraud + Good Theft by the Private Landlord. It was timed to coincide with the Basildon Crown Court Public Gallery Assault Framing Fraud Trial Plea Hearing. The Theft Event deprived Mr Nkrumah of the cash needed to pay the train fare and the Case Papers. The Plea Hearing Audio Record is Travel Warrant Refusal Proof against the Crown Court Judge. The Cash Theft, Travel Warrant Refusal and Return Journey got Ambush Set – Up Conditions for an Assault Framing Fraud by Railway Station Security Officers, British rail Police and Essex Police.
9. Everything that could go wrong for the Protection Fraud Network did go wrong. Mr Nkrumah had Framing Fraud Suspicions and avoided the Close Contact. He used his right hand as a pivot and threw his body over the Single Gate Ticket Barrier. The Side Camera and Front Camera got Event Videos. The Side Camera Video has a Distinctive Frame. His face is recognisable because it was close to the hand pivot and moved slowly, but his feet are a streak of light because they moved fast. The Prosecution File is Fraud Conspiracy Proof against the Event Witnesses, Video Expert, Investigators and Prosecutors. The Court Records are Fraud Conspiracy Proof against all of them and All Supervision Judges and All Case Judges.
10. Motor Trial Frauds by Essex Magistrates used Public Gallery Assault Framing Frauds by Essex Police. A Plea Hearing Fraud Report got a Confidence Collapse and Case Transfer from Essex to Hertfordshire by the Resident Judge. It got Plea Hearing Frauds and a Remand Fraud by Hertfordshire Magistrates, and then Contempt Fraud Findings + Case Transfers by Crown Court Judges from St Albans to Chelmsford and then to Basildon, where it got Plea Hearing Frauds, a series of Case Management Frauds and then a Confidence Collapse and Case Transfer to Snaresbrook Crown Court.
11. The Goods Theft and Electronic Devices Dump by the Private Landlord in the Clearance Skip got a Sighting Report from a Fri end and Stolen Goods Recovery Help Request by Mr Nkrumah that got an Assault Framing Fraud Arrest by the Metropolitan Police, Case 2022 0043 Trial Fraud Plan by the Crown Court. It used Hearing Notice Denial Frauds to get an Appearance Failure, In Absence Trial Fraud, Conviction Fraud and Arrest Warrant Fraud. It failed. A Confidence Collapse got a Hearing Date from a Court Officer, Case Refusals by more than 100 Crown Prosecutors, Trial Appearances by the Framing Fraud Officers and Mr Nkrumah, and Audio Record Secret Trial Fraud Conspiracy Proof against Crown Court Judges.
12. Meanwhile, other events got Child Prostitution Grooming Proof against the Childrens' Mother and Theft Agent, and Protection Fraud Conspiracy Proof against Barking and Dagenham Council, Metropolitan Police and Cabinet. All of it enables the Eastern Command Area Enquiry Proposal and expansion of it to include Essex and England. The Enquiry Proposals will get Election Credibility Proof for the Proposer MPs and Election Incredibility Proof against Resister MPs.
