Greetings Victoria,

Thank you for your attached single assessment Victoria.

Just a few rectifications.

My contact on file should be 07773311449, which is the contact we have been communicating on so that I don't miss any contact attempt especially the FGC to be arranged.

From the report my side of events have not been sought about the allegations that Laetticia have laid over the years. I am quite surprised about Kenina's views about me and have been making effort to have a relationship with her, however it doesn't help when there is discord between the progenitors and Laetticia is coercing Kenina to be against me and discredit me because I try to encourage consistent behaviour and discipline in the home, which I have evidence and reflective in how Kenina communicates with me or how she behaves every time there is disagreement between me and Laetticia.

With regards to Kenina going missing after school, it was Benjamin Koomson's (who is not a family uncle and rather became a friend since opening the shop in Summer 2021) shop that Kenina had ended up at without us being notified by

her or Benjamin Koomson and her phone being off. And this is the same man that I have strong suspicion and relative accounts of him grooming Laetticia and Kenina and sexually exploiting them, which raises serious child risk concerns which I am being excluded from being able to get more evidence on. Kenina wrote a poem that 'I'm only 13' which was on her door. Benjamin had also told me that Kenina does give in easily when you grab her, however did not think much of it at the time, and had repeatedly asked to teach Kenina, but knowing his perverted innuendos and sexual perverseness, I refrained from accepting his offers, in addition to him showing sexual inappropriate images in book to a roughly 9 year old girl that he was supposed to be teaching in the dining area of his shop as I overlooked. In addition to self-harm marks that I have seen on her arm I should have in hindsight paid attention to the potential grooming and sexual exploitation of Kenina. Not long after these incidents is when Laetticia travelled with Kenina to Congo and I solely cared for the boys and yet Laetticia makes allegations of me trying to cause immigration issues to stop her. The school has not been helpful as when large amounts of money was found with Kenina and I wanted to investigate, the school communicated with Laetticia instead however when they wrote it in a letter they said both parents had given the explanation.

It is all suspicious that my questions to Kenina about her whereabouts has been directed to being about where she is with her mother. Laetticia was not monitoring Kenina on Life 360 App as stated and it was rather me doing it and informing Laetticia to keep an eye on Kenina's whereabouts until Laetticia and her sisters Mariette and Geordicia demanded that Kenina turns it off after I raised concerns about Kenina's whereabouts. When Kenina was missing from athletics training on Thursday 21 November 2024, it was me that discovered that Kenina had gone skating at an unnotified location and I discovered and informed Laetticia who was at church and had no idea of Kenina's whereabouts. The Children's welfare is paramount and the Children Exposure and Potential Grooming Risks are a serious concern. Ali has been to the hospital twice in the past few month for unexplainable infections.

Please clarify when I made threats to you to take legal action against the police and children services; what I had actually said to you when you asked why I had not reported my concerns to the police is that I was waiting for the police to contact me so that I can make an official report on record from Laetticia's initial report to as she had told me that the police said they will be in contact, and I added that I cannot trust the police to approach them in these circumstances from how they have treated the family, and especially me in the past, which was proven when I reported my suspicions to them with the CAD 8820/05Nov24, which they have not any follow up with me to date. Nevertheless, when Laetticia reported my concern the police on 01 November with the CAD 4224/01Nov24 to exonerate and vindicate herself and get a pre-investigation case closure, they came to speak to her on the same day and when I followed up with her she said again that the police said they will be contacting me, however I have still not received any contact from the police to date. When you also called me at 16:06 on Friday 22 Nov to say that you will be looking to close the case, you assured me that the police investigation into my concerns is still ongoing, and that the police will be in contact, however please note that the police have still not been in contact. Please clarify that if the investigation of my concerns is ongoing, then why is it a No against Child Sexual Exploitation Concern?

I will also appreciate being informed of the erratic behaviour and its impact on the children so that I can address it as I want the best for the children. It seems that the children are being coerced and being unfairly as Laetticia called me yesterday that she wanted to speak in my presence with Asafo, however there were periods of silence of unexplained silence of me being muted during the call and not hearing what was going on in the background and there were other undisclosed people listening in on the call. What can be done so that the children are not subjected to such coercive behaviour?

Laetticia has been expressing since July 2022 that I am being a good father and doing everything right so it is very concerning and suspicious that the Children Risk concerns is making her so determined to undermine and isolate me from the children. The very fact that she is predetermined to state that if anything was to happen to her the children should be assessed to go to her family is concerning when she is aware that risks with her family did not allow the children to be placed with them on the previous assessment.

With regards to Domestic Abuse, has it been considered how I have been abused and manipulated, and the impact it has on me?

Please confirm if the MARAC referral has been made as it was not stated in your Goodbye letter.

I look forward to the issues being resolved and the children welfare being properly safeguarded.

The Police I believe may contact you as well. I will advise you contact the Police if the concerns are still ongoing, and they haven't been in contact with you.
