### REASONS

The Coronation Oath Enforcement Authority has Corruption Remedy Powers that govern Parliament Session Powers. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Lawful Business of UK Citizens made exposure of the Election Frauds inevitable. An Election Fraud Concealment Plan used Sabotage Frauds against the Lawful Business. It discovered the Politicians had lost control of Dictator Powers to a Protection Fraud Network. Corrupt Deals got Immunity Frauds for the Network, Lawful Business Sabotage Fraud Services for the European Leader and Profit Share for Prime Minister Mr Blair. Fraud Proof Sets validated Corruption Remedy Process. In 2006 it got a Forced 10 Months Resignation Notice from Prime Minister Mr Blair. The Leadership Contest proved a Network Agents dominated the Governing Majority. Deal Frauds got a Network Profit Share for Cabinet Ministers and a Director of Public Prosecutions Appointment Fraud for Kier Starmer got Protection Frauds that included Child Prostitution. In 2021, Protection Fraud Proof against the Cabinet and Parliament validated Forced Remedies. In 2024 Forced Corruption Exposure enabled the General Election to a Big Reduction of Network Agents in Parliament.

The 2024 Parliament Session Grant Conditions required the Mass Release of 20,000 Political Prisoners. It got Release Fraud Proof and a Corruption Exposure + Dismissal Decision against the Cabinet. It needed New Child Prostitution Proof against Cabinet Officers. Investigations 01YE5144123 and 01KW635924 got it. Production Demands for Fraud Proof as Defence Evidence got Case References by the Investigators via superiors to Commissioner Rank Police. The Reference Reason was that no wanted responsibility for Interview Audio Records of Fraud Proof Production Demands that got Production Failure Fraud Proof against the Investigator or Demand Failure Fraud Proof against the Defender, or Case Closure Frauds. Case References by Commissioner Rank got Child Prostitution Conspiracy Proof against the Home Secretary Ms Cooper and Prime Minister Sir Keir Starmer. It enabled the US Presidential Elect Team to help UK Opposition Leaders make Corruption Remedies the Key Issue for 2025 UK General Election. Discovery Statements by Commissioner Rank Police will be Remedy Co-operation Proof for Honourable Police Officers.

### The Entrapment Fraud

The Protection Fraud Network has National Crime Businesses managed by Top State Officers and Law Court Judges. The National Drug Crime Business is managed by Top Police, Top Drugs and Top Judges. Police Officers and Customs Officers recruit and supervise Wholesalers and Retailers. Science Teacher Mr Benjamin Koomson is a Wholesaler. The Delivery Method is Car Provision by Mr Koomson for Errand Journeys by Uninsured Drivers + Unlicensed Drivers and use of the Errand Absence Period for Drug Collection from the Car Boot by or for the Retailer. Some Errand Journeys

get Uninsured + Unlicensed Motoring Arrests + No Car Seizures + Car Provider Identity Omissions from the Prosecution Records. Some of the Errand Journeys get Mobile Contact from Mr Koomson to the Driver with Event Observation by Police Officers for Motoring Offence Arrests. They are Entrapment Frauds. Investigation Denial Frauds + Prosecution Frauds got a Secret Trial Fraud + Secret Conviction Fraud + Secret Sentence Fraud that were discovered by a Licence Renewal Application after the expiry of Previous Framing Frauds. The Appeal got an Appeal Reference Denial Fraud + Hearing Denial Fraud for a Timed-Out Reason Fraud.

#### Entrapment Fraud Motive

Tenancy Forgery Complaints got Corruption Whistle Blower Status by Citizen Mr Nkrumah. It motivated a Ruin Fraud Conspiracy against him. A series of Framing Frauds were Pathetic Failures. The Ruin Frauds needed Entrapment Frauds. The Ruin Frauds got Original Documents and Record Inconsistencies that were Record Fraud Proof for Corruption Investigations. Top Judges made an Investigation Sabotage Plan. It needed Original Documents Theft + Electronic Device Thefts. Top Judges gave the Electronic Device Theft Contract to Drug Dealer Mr Koomson. It needed penetration of the Family Circle, management of the process that got Device Location for the Device Theft. Bad Execution got the Device Theft but Compelling Proof against the Theft Conspirators. Drug Dealer Mr Koomson could not resist the temptation for prostitution of the Chronically Immature Mother of the 3 children and Child Prostitution of the 15-year-old daughter. Electronic Records were Prostitution Grooming Proof. Guilty Individuals needed an Electronic Devices Theft and used Harassment Complaint Fraud 01KW635924 to get an Arrest Fraud + Electronic Devices Seizure Fraud. Everything that could go wrong for the Child Prostitution Groomers did go wrong. Rape Investigation 01YE1544123 was used for Production Demands of Corruption Proof as Defence Evidence. It got Case References from the Investigator that enabled Commissioner Rank Police to get Protection Fraud Liability Proof against the Home Secretary Ms Yvette Cooper and Prime Minister Sir Keir Starmer. Corruption Cases were used for Additional Evidence Notices that got New Court Frauds and Protection Fraud Proof against the Home Secretary and Prime Minister. Additional Evidence Notices by Mr Nkrumah got a Child Prostitution Grooming Protection Fraud Proof in time for the Child Prostitution Scandal. It is a Live Case for the Child Prostitution Enquiry.
