Investigation 01YE1544123 Closure Proof Demand + Seized Goods Return

To: Metropolitan Police + Justice Ministry + Cabinet + Court of Appeal + Parliament

Disclosure Demand for Investigation Closure + Seized Goods Return for the Stated Reasons that:

1. A Rape Complaint Fraud by the Complainant and Gender Bias Frauds by the Metropolitan Police got Investigation 01YE\$1544123, an Arrest Fraud and Goods Seizure Frauds and Bail Conditions that were a Family Sabotage Fraud and Defence Evidence Access Denial Fraud.
2. The Arrest Caution included the warning that failure to mention Defence Evidence might prejudice the Defence Case got Defence Evidence Enquiry Failure Proof against the State Provided Defender.
3. The Bail Conditions Appeal got Process Denial Fraud Proof against the State Approved Defender, Investigator and Law Courts and Conflict Qualification Pretence Fraud Proof against the Defender and Investigator
4. The Production Demand for Corruption Proof as Defence Evidence got a 1st Bail Return Appointment Appearance Failure by the Investigator and Defender on 21st March 2024 and Evidence Production Failure Fraud Proof and 2nd Interview Failure Fraud Proof against the Investigator.
5. The Bail Conditions Application by 2 Grandsons and Equity Lawyer Mr Ellis got Process Denial Fraud Proof against the State Approved Defender, Investigator and Law Courts
6. Live Corruption Case Additional Evidence Notices from Citizens added to the Evidence Production Failure Fraud Proof and 2nd Interview Failure Fraud Proof against the Investigator. The Additional Evidence included use of a Blackmail Fraud for Child Prostitution.
7. The 2nd Bail Return Appointment on 21st June 2024 got an Appearance Failure by the Investigator and Defender and Evidence Production Failure Fraud Proof and 2nd Interview Failure Fraud Proof against the Investigator.
8. The 3rd Bail Return Date got a Magistrates Court Bail Extension Application Notice from the Investigator got No Service from the State Defender and Response Acknowledgement Failure Fraud Proof + Hearing Denial Fraud Proof against the Defender, Investigator and Magistrates Court.
9. The Contempt Fraud Claim KB 2024 004256 Remedy Application of the Citizen got from the Applications Court on 20th December 2024 a Dismissal + Totally Without Merit Certificate + Reasons from Justice Mr Johnson in Citizen Mr Katsiaounis v Cabinet + Justice Ministry + Metropolitan Police
10. The Fraud Appeal got a False Out of Time Claim by the Court of Appeal and Compliance Time Limits that were Case Management Incapacity Exploitation Frauds
11. The Closure Proof Demand will get either Closure Proof + Seizure Goods Return that add to the Fraud Proof or New Grounds for Repeat Remedy Action in the High Court
12. Case References by the Investigator and Commissioner Rank Police got Protection Fraud Proof against the Cabinet that includes Child Prostitution.
