Public Gallery Assault Framing Fraud 22 CA 10743 23 Case Status Request for the Reason that:

1. The Osteopath Misdescription Framing Fraud by the General Osteopath Council against Citizen Ms Davies used Jurisdiction Trial Misrepresentation Frauds + Jurisdiction Witness Exclusion Frauds by the Crown Court Officers. Equity Lawyer Mr Edward Ellis was the Jurisdiction Witness. He made the case that the Exclusion Rule applied to Fact Witnesses, to control the Fact Evidence Change Risk, but not Jurisdiction Witnesses because they could not change Official Records. A Public Gallery Removal Service Call got Public Gallery Criminal Trespass + Assault Investigation Fraud + Arrest Fraud + Custody Fraud against Equity Lawyer Mr Ellis by West Mercia Police and then Jurisdiction Trial Denial Fraud by the Prosecution and Crown Court. The Crown Court Audio Records were the Fraud Proof.
2. The Arrest Caution and the Interview Caution included 'it may harm your defence case if you fail to mention anything that later you wish to use in court'.
3. The Caution Response was a Production Demand for Corruption Proof got by Citizen Ms Davies and others against the State, Profession Authorities and Law Courts as Defence Evidence. It got Body Cam Records + Custody Reception Desk Video and Audio Records + Interview Audio Records of the Production Demand and Production Failures that were Fraud Conspiracy Proof against the Investigators and Prosecutors.
4. The Assault Trial Fraud 22 CA 10743 23 Defence + Remedy Applications + Custody Refusal Notice + Vulnerability Notice + Special Needs Notice dated 24<sup>th</sup> March 2023 and 7<sup>th</sup> April 2023 and the of Equity Lawyer Mr Ellis v West Mercia Police and the Royal Commission Filing + Service Email dated at 02 38 on 12<sup>th</sup> April 2023 got No Substantive Response from the State, Law Courts or Parliament.
5. The Bail Surrender got No Disclosures from the State or Law Courts to the Equity Lawyer.
6. In 2025 the US Presidential Elect Team and the UK Opposition Leaders used the Child Prostitution Scandal to get a Forced Response from the Cabinet. It was that the Lunatic Allegation that Child Prostitution Complaints were Right Wing Activism and Child Prostitution Enquiry Limit Frauds. They were Protection Fraud Proof against the Cabinet. It made Corruption Remedies the Key Issue for the next UK General Election.
7. The Assault Trial 22 CA 10743 23 got Case Process Secrecy Fraud Proof against the State and the Magistrates Court. All of it is Relevant Evidence for All Citizens in All Cases including the Child Prostitution Enquiry.
8. All Corruption Proof is Relevant Evidence for the Child Prostitution Enquiry.

10. The Basildon Assault Framing Fraud Trial 2023 0058 is a Corruption Remedy Process Test Case. The Framing Fraud Motive was to do Discredit Damage to Citizen Mr Nkrumah. Competent Case Management got Electronic Records that were Fraud Corruption Proof against the Authorities. Top Judges made a Corruption Investigation Sabotage Plan. It needed Electronic Devices Thefts. Science Teacher Mr Benjamin Koomson was chosen as Theft Agent because he managed Wholesale Distribution for Top Drug Dealers. The Basildon Assault Framing Fraud was timed to coincide with the Theft Event. The Prosecution File is Innocence Evidence Concealment Fraud Proof against the State, and Contempt Immunity Fraud Proof against the Magistrates Court, Crown Court, High Court and Court of Appeal. Everything that could go wrong for the Fraud Conspirators did go wrong. The Drug Dealer could not resist Prostitution of the Immature Mother of the Nkrumah Children and Prostitution grooming of the 15 – Year – Old Daughter. It is a Live Child Prostitution Case that in 2024 and 2025 got Protection Fraud Proof against the Home Secretary and Prime Minister.
