Contempt Claim KB 2025 000715 Case Management Co-operation Offer

1. Joint Demand for:
 - 1.1. A SEALED Claim Form Service Failure Explanation by the High Court Actions Office
 - 1.2. Written Reasons for the Child Prostitution Witness Protection Refusal + No Merit Certificate
For the REASONS that they are needed for a Child Prostitution Protection Denial Fraud Appeal to the Court of Appeal
2. Child Prostitution Witness Protection Denial Fraud + No Merit Certificate Joint Appeal for the REASONS that:
 - 2.1. The Coronation Oath Enforcement Authority has Corruption Remedy Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority Responsibilities of Parliament.
 - 2.2. In 2004 they got Top Level Corruption Proof. They used it to start a Corruption Remedy Process that has continued ever since.
 - 2.3. The Remedy Process discovered the Protection Fraud Network has National Crime Businesses managed by Top State Officers and Top Judges. Top Police, Top Customs and Top Judges manage the National Drugs Crime Business. Top Drug Sales go with Protection Frauds that included Child Prostitution.
 - 2.4. In 2023 the Remedy Process got an International Agreement for Remedy Enforcement against Fraud Profiteers. In 2024 the International Agreement got Damage Payments that financed the Post Office Scandal and Health Scandals.
 - 2.5. Scandal Exposure enabled the 2024 General Election to break the Remedy Denial Majority in Parliament that the Protection Fraud Network controlled. They retained Cabinet Control.
 - 2.6. The Remedy Process needed the Child Prostitution Scandal to get Cabinet Control from the Protection Fraud Network.
 - 2.7. Citizen Mr Nkrumah got Child Prostitution Proof against the Children's Immature Mather and Protection Fraud Drug Distributer Mr Benjamin Koomson. The Rape Complaint Blackmail Statement dated 14th October 2024 of Citizen Mr Nkrumah was Additional Evidence for Rape Investigation 01YE1544123. Additional Evidence Case References from the Investigator and Commissioner Rank Police got Protection Fraud Proof against Home Secretary Ms Cooper and Prime Minister Sir Keir Starmer. They were Live Case Preparations for the Child Prostitution Scandal. It enabled Remedy Co-operation Blackmail by the Coronation Oath Enforcement Authority against the Cabinet.
 - 2.8. The Contempt Claim KB 2025 000715 + Child Prostitution Witness Protection Application got Protection Fraud Conspiracy Proof for Citizen Mr Nkrumah against the High Court and a Fraud Procurement Presumption against the Defendants and Interested Parties that is subject to Rebuttal Proof Positive
 - 2.9. The Case Management Co-operation Offer by Citizen Mr Nkrumah gives the Cabinet and Opposition Leaders a chance to create Rebuttal Proof Positive. All they have to do is collaborate in the Joint Demand and Joint Appeal
