2023 0058 Defence + Counter Charge

The Charges of Assault and Criminal Damage are the Crime Proceeds of a Criminal Conspiracy for Justice Perversion to provide Protection Frauds for Corrupt Officers of Housing Associations, the State, Cabinet and Judiciary.

Many thousand Forged Tenancies were the Commitment Proof provided by Housing Association Officers Corruption Whistle Blowing by Citizen Mr Nkrumah motivated a Housing Association Officers to get Protection Frauds from the Judiciary. Forgery Complaint got Whistle Blower Status for Tenant Mr Nkrumah. They motivated Protection Fraud Demands by Housing Officers and Cabinet Officers. Service Calls by Top Judges got Framing Fraud Expert Resource Allocation Orders from Top Police and Framing Frauds against Mr Nkrumah. A Profit Share Demand by Top Police got a Profit Share Refusal from Top Judges. It got a Service Refusal by Top Police.

Mr Nkrumah was born in 1983, had 4 A Levels, Bureaucratic Competence and Computer Skills. His Stress Response Behaviour was to make Applications, Claims and Complaints. It got Seal Ink on Original Documents and Electronic Record Inconsistencies that were Record Fraud Proof against the Law Courts. It Confidence Collapses in the capacity of the Judiciary. Top Judges made a Protection Fraud Plan. It needed Original Documents Theft and Electronic Device Thefts. Citizen Mr Nkrumah was homeless. They did not know where he kept the Original Documents and Electronic Devices. They needed Theft Target Locations.

In September 2020 a Hearing Event got Original Document Production from a Big Blue Bag by Citizen Mr Nkrumah. It got an Original Document Location Report from a Court Officers, Big Bag Theft Order from a

Representation Fitness Test of Court Appointed Defender for Citizen Mr Nkrumah

12th March 2025

Top Judges and use of the Return Journey and a Theft Agent for a Big Bag Snatch Theft as soon as Citizen Mr Nkrumah left Seven Sisters Station.

The Electronic Device Theft needed a process that persuaded Citizen Mr Nkrumah to put All Devices in One Location. Science Teacher Mr Koomson is a Metropolitan Police East Command Wholesale Drugs Distributer for the Protection Fraud Network. Top Judges gave Drug Dealer Mr Koomson the Electronic Device Theft Contract. He infiltrated the Family Circle, persuaded the Nkrumah Children's Immature Mother to move, and procured Residential Tenancy Misrepresentation Frauds from the Private Landlord that persuaded Citizen Mr Nkrumah to put his Cash + Electronic Devices + Case Documents + Other Goods in the house, and then procured All Good Theft by the Private Landlord. It was timed to deprive him of the Case Records and Train Fare needed to attend the Public Gallery Assault Framing Fraud 2021 0540 Plea Hearing on 2nd November 2021 in Basildon Crown Court. A Travel Warrant Request by Citizen Mr Nkrumah got a Warrant Refusal by the Plea Hearing Judge Ms Cohen. The Return Journey was used for an Ambush Assault Framing Fraud at Basildon Trailway Station. The Video Records are Contact Avoidance Proof for Citizen Mr Nkrumah and Framing Fraud Conspiracy Proof against the Prosecution Witnesses. The Interview Audio Record evidences the existence of Contact Avoidance Video Proof. The Video Compilation and Unused Material Records are part of the Innocence Evidence Concealment Fraud Proof.

The Public Gallery Assault Framing Fraud Trial 2023 0540 got a Case Transfer to Snaresbrook Crown Court and Case Reference 2023 1180 and many adjournments to 2026.

The Trial 93JD1394221 2100279461 and Appeal Retrial 2023 0058 Evidence Productions Applications got Production Orders, Order Breach Contempt Fraud Proof against the State and Contempt Immunity Fraud Proof against the Magistrates and Crown Courts.

The Electronic Device Theft was badly managed. A Stolen Electronic Device Dump by the Private Landlord in the House Clearance Skip got a Stolen Goods Location Report from a Friend, a Stolen Goods Retrieval Help Request by Citizen Mr Nkrumah and a Good Retrieval Site Meeting that a Metropolitan Police Officer used for an Assault Framing Fraud and Trial 2023 0043. Every stage of the process got Fraud Conspiracy Proof against the State and Law Courts. Top Judges made a Secret Trial Fraud Plan. It used Hearing Notice Denial Frauds to get an Appearance Failure + In Absence Trial Fraud + Conviction Fraud + Arrest Warrant Fraud. On Wednesday 23rd March 2023 a Confidence Collapse got a Hearing Date from a Court Officer, on the Thursday and Friday Case Refusals by more than 100 Crown Prosecutors and on Monday 27 March 2023 2 Trial Appearances by the Framing Fraud Officers and Citizen Mr Nkrumah, and Audio Records that are Fraud Conspiracy Proof against Crown Court Judges.

On 8th November 2011 the 2023 0058 Case Management Hearing got a Cross Examination Restraint Order with No Advocate Appointment and as Trail Date for 7th March 2025. The Public Gallery Plea Hearing Judge Ms Cohen, who made the Travel Warrant Refusal, sat for the Basildon Assault Framing Fraud Trial 2023 0058 on 7th March 2025. A Conflict Disqualification Recusal Application by Citizen Mr Nkrumah got a Recusal Refusal Fraud + Cross Examination Restraint Fraud + Defender Appointment Fraud + Direction Frauds + Contempt Remedy Denial Frauds + Child Prostitution Witness Protection Denial Frauds by Judge Ms Cohen. Investigation is needed to discover how many Case Refusals by Crown Court Judges and Advocates before the Trial Allocation to Judge Ms Cohen and the Advocate Appointment of Counsel Mr Daniel Setter on 6th March 2025.
