

### Child Prostitution Enquiry Case Notice

High Court Case Issue Denial Fraud Complaint that Case Filing + Fee Payment on 19<sup>th</sup> August 2024 got No Service until Day 204 when it got a Case Papers Refusal that used the Wrong Form Reason Fraud.

#### Circumstances

The Coronation Oath Enforcement Authority have Corruption Remedy Jurisdictions that govern Parliament Session Powers. They manage the Profession Governance Responsibilities of Parliament.

The Dictator Governance Plan for Western Europe vested a Remedy Powers Monopoly in the State. It used Sabotage Frauds against the Coronation Oath Enforcement Authority. Evidence Frauds denied a Reliable Supply of Admissible Evidence. Education Frauds denied any mention of it in Academic Curricula and Professional Qualification Curricula. The intent was that everyone would forget how to service it and then forget it existed. The Sabotage Frauds got a Dormancy Period for the Coronation Oath Enforcement Authority. The Gnostic Christians made an Equity Governance Recovery Plan. It needed Criminal Conspiracy Proof against a serving Prime Minister and a Reliable Supply of Admissible Evidence.

In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Lawful Business of UK Citizens made inevitable exposure of the Election Frauds. The European Leaders made an Election Fraud Concealment Plan. It used Sabotage Frauds against the Lawful Business. They were Extradition Frauds against a UK Citizen and Imprisonment Frauds against him and his Distribution Manager who was a Dutch Citizen. Everything that could go wrong for the European Leaders did go wrong. The 1<sup>st</sup> Extradition Fraud discovered the Protection Fraud Network had National Crime Businesses managed by Top State Officers and Top Judges. Top Police, Top Customs and Top Judges managed a National Drugs Crime Business. UK Customs knew about Kidnap Extradition Frauds by Individual EU States. The 1<sup>st</sup> Extradition Fraud was the first Joint Kidnap Extradition Fraud by Two European States. UK Customs did not recognise it for what it was. They thought it was cover for a Drug Carrier Movement Record Decoy Address Investigation. They got News Coverage for a Big Drugs Bust and International Co-operation and took control with intent to manage Investigation Sabotage Frauds. The 2<sup>nd</sup> Extradition Fraud got Immunity Frauds for the Top Drug Dealers, Extradition Fraud Services for the European Leaders, a Protection Fraud Network Profit Share for Prime Minister Mr Blair, Cabinet Control for the Protection Fraud Network, Revived Active Service of the Coronation Oath Enforcement Authority and a Corruption Remedy Process that has continued ever since.

In 2023 the Remedy Process used Imprisonment Fraud Proof against the Judiciary to get an International Agreement for Remedy Enforcement against Fraud Profiteers. In 2024 it got Damage Payments from Fraud Profiteers for the Post Office Scandal and Health Scandals. Corruption Exposure got an increase in the MP Retirement Rate, an Incredible Choice and Choice, and a Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Novice Governing Majority led by the Top Network Agent, Sir Keir Starmer. The Network lost a Remedy Denial Majority in Parliament but kept Cabinet Control.

The Remedy Process needed to get Cabinet Control. In early 2025 they needed a United Electorate to do it. They used the US President Elect Team, UK Opposition Leaders and Child Prostitution Scandal to get Child Prostitution Enquiry and make Corruption Remedies the Key Issue for the next General Election. It will get Forced Corruption Remedy Commitments from All Candidates and a Corruption Remedy Mandate from the next Governing Majority regardless of who is Prime Minister. It will get Dismissal Executions against the Judiciary by a United Parliament, Victim Identification and Case Remedies.

The Remedy Process needed Test Cases to service the Child Prostitution Enquiry. The Election Fraud Claim of Citizen Dr Spivack was filed on 28<sup>th</sup> June 2024 and the Tax Fraud Claim of Citizen Ms Davies was filed on 19<sup>th</sup> August 2024. They got Process Denial Fraud Proof against the High Court. Other Test Cases caused Confidence Collapses in the Protection Fraud Network. Election Claim Filing Day 252 got a Fee Remission Certificate Demand and the Tax Fraud Claim Filing Day 204 got a Filing Acknowledgment and use of an Old Form Claim Reason Fraud for a Process Denial Fraud. The Common Law governs the Test Cases. Notice is enough. The Old Forms were enough for Effective Notice.
