Brief Case Facts with Complete Disclosure Rights Reserved

Corruption Remedies needs NEW Child Prostitution Protection Fraud Proof.

The Nkrumah Cases got Child Prostitution Protection Fraud Proof against the Fraud Profiteers, Police and Council

A Criminal Conspiracy by Housing Association Officers, State Officers and the Judiciary was to commit Profit Frauds against Housing Associations with Protection Frauds from the Law Courts. The Protection Fraud Deal required Fraud Commitment Proof from the Housing Officers before the Protection Fraud Supply. Many thousand Forged Tenancies were part of the Fraud Commitment Proof provided by the Housing Officers. Forgery Complaints by Tenant Mr Nkrumah was an Exposure Risk. Protection fraud Demands by Housing Officers, State Officers and Cabinet Officers got a Service Call by Top Judges, Framing Fraud Orders by Top Police and Framing Frauds by the Metropolitan Police. A Profit Share Demand by Top Police got a Share Refusal by Top Judges and a Framing Fraud Expert Resource Allocation Refusal by Top Police. Service Calls by Court Officers got Service Refusals by Competent Police Officers and Incompetent Efforts by Idiot Officers.

Sample Framing Frauds are to start the Complaint Process. A Police Impersonation Framing Fraud used Physical Possession of an Athletic Training Whistle. A Drug Crime Framing Fraud used a Half-Eaten Shia Butter Packet for White Substance Suspicion Fraud because the Idiot Officers had failed to equip themselves with a Drug Supply for a Drug Crime Framing Fraud. They used it for Arrest Frauds + Bail Conditions Frauds that did Family Sabotage Damage.

The Initial Framing Frauds by Corrupt Police got Record Frauds that enabled Initial Family Sabotage Frauds by Corrupt Council Officers.

Mr Nkrumah was born in 1983, had 4 A Levels, computer skills and Bureaucratic Confidence. His Stress Response Behaviour was to use Electronic Devices for applications, claims and complaints. They got Forensic Test Material for Record Fraud Investigations. It was the Seal Ink on Original Documents and the Record Inconsistencies of the State and Law Courts. In early 2020 Mr Nkrumah discovered the Coronation Oath Enforcement Authority and the Corruption Remedy Process they manage. He gave the Remedy Process use of his cases for Integrity Tests of the Authorities. Top Judges made a Record Fraud Investigation Sabotage Plan. It needed an Original Documents Theft and an Electronic Device Theft. They needed Theft Target Locations. Mr Nkrumah was homeless. He had 3 children with Laetticia Musaka. She and the Maternal Relatives were Chronically Immature. She was very dependent on him for Child Care Services.

In September 2020 a Hearing Event got Original Document Production from a Big Blue Bag by Citizen Mr Nkrumah, a Big Blue Bag Location Report by Court Officers, a Big Blue Bag Snatch Theft Order from Top Judges and use of the Return Journey and Theft Agent for a Big Blue Bag Snatch Theft from Citizen Mr Nkrumah when he left Seven Sisters Station.

The Electronic Device Theft needed all Target Devices in One Location. It needed a Theft Manager to penetrate the Family Circle and manage a process that persuaded Mr Nkrumah to put All Electronic Devices in One Location. It needed someone who had Trusted Agent Status with the Top Judges was could present with Credible Respectability to Theft Victim Mr Nkrumah. He would reject an Obvious Criminal. Science Teacher Mr Benjamin Koomson was the Local Wholesale Manager for the National Drug Crime Business of the Protection Fraud Network. He had Trusted Agent Status with the Top Judges. He was not an Obvious Criminal. They gave him the Theft Contract. He opened a shop and used the Maternal Relatives to penetrated the Family Circle. He pretended to befriend Mr Nkrumah. He asked

## **Government Fraud Maladministration Complaint**

him to look after the shop. It ensured he knew where Mr Nkrumah was when spent time with the Immature Mother, Ms Laetticia Mukasa. He persuaded her to move house, procured Tenancy Misrepresentation Frauds by the Private Landlord, procured Cash + Electronic Devices + Case Papers + Other Goods placement in the house by Mr Nkrumah and procured All Goods Theft by the Private Landlord. It was timed to deprived him of the Case Papers and Train Fare Cash needed for the Public Gallery Framing Fraud 2021 0540 Plea Hearing in Basildon Crown Court. The Plea Hearing got an Audio Record of a Travel Warrant Application by Mr Nkrumah and Warrant Refusal by Ple Hearing Judge Ms Cohen. Top Judges needed a Discredit Fraud against Mr Nkrumah. They used the Return Journey and Basildon Railway Station for an Ambush Assault Framing Fraud. Travel Warrant Requests with a Reasons Explanation got Refusal Behaviour from Ticket Officers and Hostile Behaviour from Security Officers who were together at the Wide Security Gate. It raised Framing Fraud Suspicions. It motivated Contract Avoidance by Mr Nkrumah. He used his right hand as a pivot and threw his body over the Single Ticket Barrier. The Side Video has a Single Frame in which his face is recognisable because it was close to the Pivot Hand and moved slowly, but the feet were a streak of light because they moved fast. It was Contact Avoidance Proof + Assault innocence Proof for him and Fraud Proof against the Framing Fraud Conspirators. The Case Investigators did not know that when they conducted the Recorded Interview. The Audio Records is Corruption Case Notice Proof and Single Ticket Barrier Video Contact Avoidance Proof for Mr Nkrumah and Fraud Proof against the Framing Fraud Conspirators. The Framing Fraud got Innocence Evidence Concealment Fraud against the Investigators, Prosecutors, Trial Adjudicators and Appeal Adjudicators at every stage of the Magistrates Court Trial 2100279461 and Crown Court Appeal 2023 0058.

A Stolen Electronic Device Dump by the Private Landlord in the House Clearance Skip, got a Stolen Goods Location Report from a Friend, a Stolen Goods Retrieval Help Request by Mr Nkrumah and Retrieval Site Attendance by an Idiot Officer. He knew that Protection Frauds needed a Goods Retrieval Failure. He used the Retrieval Event for the Romford Assault Framing Fraud against Mr Nkrumah. It got Trial 2022 0043 and a series of Confidence Collapses by Crown Court Judges at Snaresbrook. The Plea Hearing got an Audio Record of Jurisdiction Trial Denial Frauds and then a 1<sup>st</sup> Confidence Collapse and a Jurisdiction Trial Order. The 2<sup>nd</sup> Confidence Collapse got Records Destruction and use of the Jurisdiction Trial Listing for a Jurisdiction Trial Denial + No Case Records Admission + Mention Hearing Pretence Fraud + Trial Frauds by the Hearing Judge. Evidence Production Orders got Order Breach Contempt Proof against the State, Contempt Immunity Fraud Proof against the Crown Court and a series of Confidence Collapses and Repeat Court Frauds. Top Judges made a Secret Trial Fraud Plan. It used Hearing Notice Denial Frauds to get a Trial Appearance Failure, In Absence Trial Fraud, Conviction Fraud and Arrest Warrant Fraud. It failed. On Wednesday 23<sup>rd</sup> March 2023 a Confidence Collapse by a Court Officer got Trial Date, on Thursday and Friday it got Case Refusals by more than 100 Crown Prosecutors and on Monday 27<sup>th</sup> March 2023 it got Trial Appearances by the Framing Fraud Officers and Citizen Nr Nkrumah, and Appearance Failure by the Crown Prosecutor and Audio Records that are Secret Trial Fraud Conspiracy Proof against the Witnesses, Investigators, Prosecutors and Judges. The last Confidence Collapse got an Adjournment Order from May 2024 to an Unspecified Date in 2026.

Public Gallery Assault Framing Fraud 2021 0540 got a Confidence Collapse and Case Transfer from Basildon to Snaresbrook, Case Reference 2023 1180 and another Confidence Collapse and Adjournment Order from May 2024 to an Unspecified Date in 2026. In 2021 it started in Essex. Confidence Collapses got Case Transfers to Hertfordshire, and then Confidence Collapses and a Crown Court Case Transfers from St Albans to Chelmsford and Basildon. It is Remedy Denial Fraud Proof against about 50 Crown Court Judges.

The Theft Contract got Prostitution Opportunities for Drug Wholesaler Mr Koomson. He started with the Immature Mother Ms Laetticia Koomson. She aided and abetted Prostitution Grooming of the 15-Year-Old Kenina. Under Age Sex Questions by Mr Nkrumah motivated Rape Complaint fraud Blackmail by the Immature Mothers. It motivated the Blackmail Fraud Complaint Statement dated 14<sup>th</sup> October 2024 by Mr Nkrumah. It got Protection fraud Proof against the Metropolitan Police, Barking and Dagenham Council and the Cabinet.
