

Contempt Claim 2025 00715 Protection Denial Fraud Appeal Grounds + Proposals

Appeal against the 2025 000715 Child Prostitution Witness Protection Refusal Fraud + No Merit Certificate dated 27th February 2025 of Justice Mr Soole

Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

Disclosure Order for Citizen Mr Nkrumah against the Cabinet, Ministry of Justice and Metropolitan Police that they do within 7 days, acting by the Attorney General, Ministry of Justice Chief Administration Officer and the Metropolitan Police Commissioner file and serve Explanation Statements why the court should not make a Contempt Claim Liability Order + Contempt Remedy Orders for Citizen Mr Nkrumah against the Cabinet, Ministry of Justice and Metropolitan Police
3. Disclosure Order for Citizen Mr Nkrumah against the Opposition Leaders that they do within 7 days file and serve Explanations Statements what they know about the Coronation Oath Enforcement Authority, Corruption Remedy Process, the Imprisonment Fraud Proof got by Contempt Claim KB 2023 000398 and Fraud Appeal CA 2023 000569 and SC 2023 00174 against the Judiciary, use of it for the Unfit Judiciary Scandal, Imprisonment Fraud Scandal, Protection Fraud Scandal and Enforcement Fraud Scandal, use of the Scandal Publicity for Negotiation Management that got the International Agreement for Remedy Enforcement against Fraud Profiteers, the Agreement Signing in December 2023 at the G7 Summit, the Remedy Enforcement against Fraud Profiteers for the Post Office Scandal and Health Scandals, what got the increase in the MP Retirement Rate, Incredible Choice and Split Conservative Values Vote that enabled the a Minority Vote in the 2024 General Election to return an Landslide Novice Governing Majority led by Sir Keir Starmer, the Corruption Remedy Conditions in the 2024 Parliament Session Grant, Conditions Performance or Conditions Breach by the Governing Majority, the process by which the US Presidential Elect Team and UK Opposition Leaders used the Child Prostitution Scandal to get a United Electorate and get Corruption Remedies in the Parliament Session or make Corruption Remedies the Key Issue for the next General Election that gets Forced Remedy Commitments from All Candidates and a Forced Remedy Mandate for whoever gets a Governing Majority.
4. Contempt Directions Hearing in Royal Court 3 at noon on March 2025.

REASONS

The Coronation Oath Enforcement Authority have Corruption Remedy Jurisdictions that govern Parliament Session Powers. They manage the Profession Authority responsibilities for Parliament. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders. The Coronation Oath Enforcement Authority used it to start a Corruption Remedy Process. It has continued ever since. It uses Integrity Test Cases that get Justice Proof for, or Remedy Denial Fraud Proof + Protection Fraud Proof against, whoever has Remedy Powers. They start at the bottom of the Jurisdiction Hierarchy and work their way up. Test Cases discovered Endemic Corruption. The Protection Fraud Network had National Crime Businesses managed by Top State Officers and Top Judges. Corruption Remedies needed Dismissal Executions against the Judiciary by a United Parliament, Victim Identification and Case Remedies. It needed an International Agreement for Remedy Enforcement against Fraud Profiteers. In 2021 they got Protection Fraud Proof against the Cabinet and Opposition Leaders denied a United Parliament. It created the need to get Imprisonment Fraud Proof against the Judiciary, use it to get an International Agreement for Remedy Enforcement against Fraud Profiteers, used Remedy Enforcement to finance the Post Office Scandal and Health Scandals, use the Corruption Exposure to increase the MP Retirement Rate that enabled the 2024 General Election to get a Power Transfer. Session Grant Breaches created the need to use the Child Prostitution Scandal to get a United Electorate. The Nkrumah Cases got Child Prostitution Protection Fraud Proof Sets against the State and Law Courts. The Claim 2025 000715 and the Fraud Appeal force the choice between Just Remedies and Child Prostitution Protection Frauds.
