PRODUCTION DEMAND REASON that the Magistrates Court Bail Appeal Hearing on 3 January 2025 got No Bail Conditions Pronouncement but the Crown Court Appeal Communications Log ends with the Magistrates Court No Reply Email at 22.43 on 16th March 2025 that reveals a Bail Variation on 03/ 01/ 2025 and uses a No Understanding Pretence Fraud for a Process Denial Fraud + Clarification Request Fraud
2. FRAUD COMPLAINT REASON that:
 - 2.1. The No Reply Email is Forgery Proof because it contains the Case Communications with Significant Omissions
 - 2.2. The No Reply Email has the Sole Function of breaking the Communications Chain

Crown Court 2023 0058 Case Management Disclosure Fraud Unfitness Complaint Notice

1. The Representation Test Notice with Email Filing + Service on 12th March 2025 from Equity Lawyer Mr Ellis and Email Filing + Service on 14th March 2025 from Citizen Mr Nkrumah got No Response from Appointee Counsel Mr Setter and a Forwarded Email Confirmation at 10.15 on Monday 17th March 2025 from Basildon Crown Court <basoildoncrownctcleerks@justice.gov.uk>
2. The Published Details reveal a Practicing Certificate from 01/04/2024 to 30/04/2025 but not a Registration Number.
3. The Most Credible Explanation for No Registration Number is to deny access to Registration Details
4. The Crown Court Advocate Appointment Delay from 8th November 2024 to 6th March 2025 raises Reasonable Suspicions of Case Refusals by the Magistrates Court Advocate Appointee and Others and the need for a Career Blackmail Victim for the Distress Appointment of Counsel Mr Setter.
5. Crown Court Advocate Appointee Mr Setter has a Further 7 Days to confirm or deny the Career Blackmail Allegation before completion of the Bar Standards Council Complaint Form

High Court 2022 002595 + 2024 000705 + 2025 000674 + 000715 Fraud Complaint + Production Demand:

1. The 2022 002595 + 2024 000705 Applications Refusal Fraud + Restraint Order dated 15th March 2024 in one document denies Equity Lawyer Mr Ellis 2025 002595 Claimant Status, gives it to Citizen Mr Nkrumah, denies him Interested Party Status, makes a Restraint Order against the Equity Lawyer 'in the terms attached' an omits the attached terms
2. The 2022 002595 Decision Proof Production Demand + Fraud Complaint dated 27th March 2024 of Equity Lawyer Mr Ellis got No Substantive Response from the High Court
3. The Contempt Claim of Citizen Mr Nkrumah got the Issue Seal + Reference 2025 000674 on 25th February 2025 but the Claim Application got the Case Reference 2025 000715 and an Application Refusal by Justice Mr Soole. The Claim Strike Out Order + Restraint Case Reference dated 12th March 2024 of Master Sullivan ignores the 2025 000715 Order Fraud of Justice Mr Soole and uses the 2022 002595 + 2024 000705 Order Frauds of Justice Mr Bourne and the Decision Proof Denial Frauds committed by the High Court
