Representation

The European Constitution vested a Remedy Powers Monopoly in the State. In every Member State of the European Union the Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and manage Co-ordinated Corruption. They manage Endemic Corruption. The Remedy Obligations got Bankruptcy Conditions for the EU States and UK. Corruption Remedies needed Dismissal Executions against Top Judges by United Parliaments, Victim Identification and Case Remedies. The Dismissal Executions needed Personal Responsibility Proof against Identifiable Judges. Test Cases got it. The Nkrumah Cases got a Special Proof Set. A New Business Priming Case used Forged Tenancies by Housing Association Officers as the Commitment Proof to get Protection Frauds from Top Judges. Forgery Complaints by Tenant Mr Nkrumah were an Exposure Risk. Protection Demands by Housing Officers and Cabinet Officers motivated a Service Call by Top Judges that got Framing Frauds by Top Police. A Profit Share Demand by Top Police got a Profit Share Refusal by Top Judges and a Framing Fraud Service Refusal by Top Police. Service Calls by Court Officers got Service Refusals by Competent Police Officers and Incompetent Efforts by Idiot Officers and Forensic Test Material for Record Fraud Investigations. Top Judges made an Investigation Sabotage Plan it needed Test Material Thefts + Test Material Destruction. Service Refusals by Top Police created the need to use Theft Agents. They needed someone they trusted. Science Teacher Mr Benjamin Koomson was the Local Drug Wholesaler for the Protection Fraud Network. They gave him the Electronic Device Theft Contract. He penetrated the Family Circle and managed the Electronic Device Theft badly. He could not resist prostituting the Immature Mother of the 3 Nkrumah Children and the 15-Year-Old Daughter. In early 2025 the Child Prostitution Scandal made Corruption Remedies the Key Issue for the next General Election. Test Cases got Child Prostitution Protection Fraud Conspiracy Proof for Citizen Mr Nkrumah and his 3 Children against Drug Dealer Mr Koomson, State Officers and Law Court Judges.
