Reasons
4. The Coronation Oath Enforcement Authority has Corruption Remedy Jurisdictions that govern Parliament Session Powers. In 2004 they used Top Level Corruption Proof to start a Corruption Remedy Process. It discovered the European Constitution vested a Remedy Powers Monopoly in the State and, in every Member State of the European Union, the Politicians had lost control to Crime Partnerships of State Officers and Law Court Judges. They sold Market Frauds to Organised Crime, provided Protection Frauds for the Corrupt Officers who managed them and traded Glittering Career Guarantees and Job Profits for Fraud Services by Corrupt Parliamentarians. General Elections got Governing Majorities that were subject to Remedy Denial Majorities controlled by the Protection Fraud Networks. They had National Crime Businesses managed by Top State Officers and Top Judges. They used Court Powers as a Business Asset. They managed Asset Thefts, Liability Frauds and Accounting Frauds for Crime Businesses against Citizens and the State. Endemic Corruption got Bankruptcy Conditions for the State.
5. Honourable Politicians made an Informal International Agreement that the UK would conduct Corruption Remedy Research how best to achieve Total Destruction of the Protection Fraud Network and provide a Remedy Model.
6. Standard Corruption Remedies needed Dismissal Executions by a United Parliament, Victim Identification, Case Remedies and an International Agreement for Remedy Enforcement against Fraud Profiteers. The Protection Fraud Network had control of Parliament. It created the need for Special Corruption Remedies. It needed Fraud Proof Sets against the Judiciary, and use of it by Honourable Politicians to get an International Agreement for Remedy Enforcement against Fraud Profiteers. In 2024 it got Damage Payments for the Post Office Scandal and Health Scandals. They got an increase in the MP Retirement Rate, an Incredible Choice and Split Conservative Values Majority Vote that enabled a Minority Vote to get a Landslide Majority led by Sir Keir Starmer. The Protection Fraud Network lost Parliament Control but kept Cabinet Control. It created the need to use the US President Elect Team, UK Opposition Leaders and the Child Prostitution Scandal to get a United Electorate And make Corruption Remedies the Key Issue for the next General Election. It got Blackmail Conditions that got Forced Co-operation from the Cabinet for Dismissal Executions against Top Judges by Parliament. It needed the Church of England Scandal before the Child Prostitution Scandal and coordinated management that got the Bigger Problem Interview by Former Lord Archbishop Justice Welby and the Bias Fraud Scandal against the Judiciary. The 2023 001609 Default Judgment Remedy Proposals + Reasons are a Test Opportunity that will get either Remedy Co-operation Proof for the Hearing Judge of Remedy Denial Fraud Proof against the Hearing Judge.
