Proposals

1. Case Priority for the Conflict Disqualification Fraud Case of the Citizen against All Cases of the State
2. All Cases Enforcement Stay pending delivery of Conflict Disqualification Fraud Remedies for the Citizen against the State
3. Conflict Disqualification Fraud Proof Production Order + Recorded Interview for the Citizen against the State

REASONS:

1. The Evidence Balance starts with Validity Presumption for the Citizen and Credibility Presumption for the State both of which are subject to Rebuttal Proof Positive. Fraud Proof of anything gets a Proof Burden Reversal and Fraud Presumption of everything else for the Fraud Victim against the Fraud Manager and the Fraud Beneficiary that is subject to Rebuttal Proof Positive. Fraud Proof for the Citizen against the State gets Rebuttal Proof Impossibility.
2. The Uninsured + Unlicensed Driving Framing Fraud by the Hertfordshire Police against the Unidentified Citizen used a Motor Insurance Denial Fraud for a Stop Fraud + Car Seizure Fraud + Car Impounding Fraud + Charge Fraud that got Trial Bias Fraud Conspiracy Proof + Conviction Fraud Conspiracy Proof against the State and Hertfordshire Magistrates Court and Appeal Process Denial Fraud Conspiracy Proof against the State and Crown Court.
3. The Framing Fraud created a Conflict Disqualification for the Citizen against the State and Law Courts.
4. The Framing Fraud got Inadmissible Evidence Status for the Citizen against All State Records + All Court Records
5. The Conflict Disqualification Case of the Citizen has Case Priority against All Cases of the State.
6. The Case Priority is managed by a Pending Fraud Remedies Enforcement Stay of All Cases for the Citizen against the State and Law Courts.
7. In 2016 the Unidentified Citizen discovered the Coronation Oath Enforcement Authority and that they managed a Corruption Remedy Process. He gave them use of all of his cases for Integrity Tests of the Authorities. Equity Lawyer Mr Edward Ellis managed the Integrity Tests.
8. The Remedy Process needed an International Agreement for Remedy Enforcement against Fraud Profiteers. It needed Imprisonment Fraud Conspiracy Proof against the Judiciary to get it. Contempt Claims 2022 002595 + 2023 0030 98 + Fraud Appeals 2023 000569 + 0174 of Equity Lawyer Mr Ellis and the Cabinet got it. The Parliament Sessions Court used it to make an Unfit Judiciary Finding, Imprisonment Fraud Finding, Protection Fraud Finding and Enforcement Fraud Findings. They got Forced Findings Pronouncement by Parliament with Mass Publicity. They required use of David Cameron as Foreign Secretary to get International Agreement and signature of it at the December 2023 G7 Summit.
9. In May 2023 the Protection Fraud Network used a burglary of the home of the Equity Lawyer to steal his Memory Stick Case Records for 2022 and 2023 and do Computer Damage that denied access to the Computer Disc Records. The Uninsured Driving Case Records of the Unidentified Citizen are part of the Lost Records.
10. The Records Theft creates the need for the Case Records Production Order for the Citizen against the State and Law Courts.
