A 10 Minute Late Appearance + No Apology + Apparent Anxiety of the Defendant raised Reasonable Suspicions of Protection Fraud Promises + No Appearance Instructions from Top Judges got a No Appearance Intent + Confidence Collapse + Late Appearance by the Defendant. Surprise Production of an Alleged Defence by the Defendant, No Examination Opportunity for the Claimant and Document Examination got a No Defence Document Finding + Document Return + Reassurance Behaviour for the Defendant from Master Armstrong added to the Reasonable Suspicions. The Default Judgment Denial + County Court Transfer + Totally Without Merit Certificate + Appeal Leave Refusal + Fraud Issue General Public Importance Certificate, a Refusal + Reserved Costs added to the Reasonable Suspicions. Prompting by the Equity Lawyer got the Appeal Leave + General Public Importance Application by the Claimant. A Reasons Demand by Master Armstrong and prompting by the Equity Lawyer got the Trustee Fraud Reason + Judicial Fraud Reason by the Claimant that got the Appeal Refusal + Certificate Refusal by Master Armstrong. A Talks Offer by the Equity Lawyer got Anxious Behaviour + Talks Refusal by the Defendant. The Audio Record is Incapacity Exploitation Fraud Proof for the Claimant against Master Armstrong. The choice of Bring Them Down or Go Down With Them from the Equity Lawyer got a Rapid Disappearance + Anxious Behaviour by the Defendant.

The Court Records are Self Evident Contempt Fraud Proof against All Supervision Judges and All Case Judges. It needs Remedy Management by All Relevant Authorities. Court Records evidence that Trust Fraud Notices to the Metropolitan Police Investigation 01YE1544123 Officers enabled the Commissioner Rank Officers to give Advance Notice to the Cabinet.
