

Child Prostitution Protection Fraud Claim + Restraint Papers Service Demand

Formal Demand for Electronic Service of the Family Sabotage fraud Claim Papers + Restraint Application Papers.

REASONS:

1. The Family Case will enable Integrity Tests that get either Justice Proof for the Family Court or add to Remedy Denial Fraud Proof got against the Civil and Criminal Courts.
2. Big Bad Mistakes by the Protection Fraud Network got Corruption Proof that enabled Revived Active Service of the Coronation Oath Enforcement Authority, a Corruption Remedy Process for the People and Special Target Status for Essex Judges and others.
3. The Protection Fraud Network has National Crime Businesses managed by Top State Officers and Top Judges. Top Police, Top Customs and Top Judges manage the National Drug Crime Business. Drug Imports by Customs Officers, Distribution Management by Police Officers and Protection Management and Cabinet Officers get Huge Network Profits. They use the Kent Ports and Felixstowe for the vast majority of their Drug Imports. They use Sussex Production Sites that provide a Reliable Supply of a Top-Quality Product that gets a Reliable Supply of Buffer Stocks for use managing Career Sabotage Frauds against Honest Officers. All of it got Special Target Status for Essex Judges, Kent Judges and Sussex Judges in the Corruption Remedy Process. The Protection Frauds include Child Prostitution.
4. Another Big Bad Mistake by the Protection Fraud Network made it worse for the Essex Judges. A Business Expansion Plan for Housing Association Frauds got Profit Shares for Top Politicians and Top Judges but not Top Police. Many thousand Forged Tenancies were the Fraud Commitment Proof from Housing Association Officers. Forgery Complaints by Mr Nkrumah motivated Protection Demands by Housing Officers and Top Politicians, a Service Call by Top Judges that got Framing Frauds and a Profit Share Demand by Top Police. A Profit Share Refusal by Top Politicians and Top Judges got a Service Refusal by Top Police.
5. Competent Management by Mr Nkrumah motivated Repeat Protection Demands and Repeat Service Calls that got Service Refusals by Competent Police and Incompetent Services by Idiot Police. In early 2020 Mr Nkrumah discovered the Coronation Oath Enforcement Authority and the Corruption Remedy Process. A Case Use Authority from him got Integrity Test Services by Equity Lawyer Mr Ellis and Corruption Remedy Standard Proof Sets for the Crown and Parliament Sessions Court. Original Documents Seal Ink and Inconsistent Case Records were Forensic Trest Material for Corruption Investigations. Top Judges made an Investigation Sabotage Plan. It needed Original Documents Theft and Electronic Device Thefts. In September 2020 a Hearing Event got Document Production from a Big Blue Bag by Mr Nkrumah, a Documents Location Report by Court Officers, a Big Blue Bag Theft Order by Top Judges and use of the Return Journey for a Bag Snatch Theft outside Seven Sisters Station. The Electronic Devices Theft needed a Theft Manager. Top Judges needed a Trusted Agent to service the Theft Contract. Science Teacher Mr Benjamin Koomson was the Local Distribution Manager for the Protection Fraud Network Drug Business. Top Judges gave the Electronic Device Theft Contract to him.; He befriended the Maternal Relatives of the 3 Nkrumah Children. He got an Introduction by them to Mr Nkrumah and pretended to befriend him. Shop Minding Services by Mr Nkrumah got Safe Conditions for Influence Frauds by Mr Koomson against the Chronically Immature Mother of the 3 Children. He procured a House Move by her and Tenancy Misrepresentation Frauds by the Private Landlord that persuaded Mr Nkrumah to put his Electronic Devices + Case Records + Cash + Other Goods in the house sand then Access Denial Frauds against Mr Nkrumah and Immediate Theft by the Landlord. It was timed to coincide with the Public Gallery Assault Framing Fraud 2021 0540 Plea Hearing in Basildon Crown Court. The Audio Record is Travel Warrant Refusal Proof against Plea Hearing Judge Ms Cohen. An Ambush Assault Framing Fraud used the Return Journey and Basildon Railway Station. Everything that could go wrong for the Top Judges did go wrong. The Video Records were Contact Avoidance Innocence Proof for Mr Nkrumah and Guilt Proof against the Framing Fraud Conspirators. The Landlord put the Stolen Election Devices in the House Clearance Skip. A Stolen Electronic Device Report from a Friend and Stolen Goods Recovery Help Request from Mr Nkrumah got a Stolen Goods Recovery Refusal Proof and Assault Framing Fraud Proof and Total Trap Conditions against the Investigation Sabotage Fraud Conspirators and Service Providers.
6. Drug Dealer Mr Koomson could not resist the transfer of Network Business to Personal Business and Prostitution Pimping Opportunities got by contact with the Chronically Immature Mother and 15-Year-Old Daughter. The Child Prostitution Complaint Statement dated 14th October 2024 of Mr Nkrumah, and use of it in Rape Framing Fraud Investigation 01YE1544123 got the Child Prostitution Protection Fraud Proof against the Chronically Immature Mother, Drug Dealer Mr Koomson, the Metropolitan Police, Home Secretary, Prime Minister and Law Courts before and after the Child Prostitution Scandal in early 2025. It got Blackmail Conditions and Foreed Co-operation by the Cabinet in preparations for Dismissal Executions against Top Judges by Parliament.
